Section 96.5-2-a – Discharge/Misconduct

### STATEMENT OF THE CASE:

Employer filed a timely appeal from the February 18, 2004, reference 01, decision that allowed benefits. After due notice was issued, a hearing was held on March 23, 2004. Claimant did participate. Employer did participate through Jim Jensen.

# FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant was employed as a part-time cashier through January 15, 2004 when she was discharged. Claimant was on a medical leave from January 9, 2004 until January 15. Marilyn, Human Resources Manager, gave her the leave of absence packet on January 9 and told her to have her doctor sign it but did not answer questions or explain the process to her. She attempted to

ask Marilyn about the packet on January 15 when she returned with her medical information. Marilyn told claimant she did not follow proper procedure and was not welcome to return to work. There was no notice that she needed to provide information by a date certain or face separation.

## REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes claimant was discharged from employment for no disqualifying reason.

Iowa Code Section 96.5-2-a provides:

An individual shall be disqualified for benefits:

- 2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:
- a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

871 IAC 24.32(1)a provides:

Discharge for misconduct.

- (1) Definition.
- a. "Misconduct" is defined as a deliberate act or omission by a worker which constitutes a material breach of the duties and obligations arising out of such worker's contract of employment. Misconduct as the term is used in the disqualification provision as being limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. On the other hand mere inefficiency, unsatisfactory conduct, failure in good performance as the result of inability or incapacity, inadvertencies or ordinary negligence in isolated instances, or good faith errors in judgment or discretion are not to be deemed misconduct within the meaning of the statute.

This definition has been accepted by the Iowa Supreme Court as accurately reflecting the intent of the legislature. Huntoon v. Iowa Department of Job Service, 275 N.W.2d 445, 448 (Iowa 1979).

The employer has the burden of proof in establishing disqualifying job misconduct. <u>Cosper v. lowa Department of Job Service</u>, 321 N.W.2d 6 (lowa 1982). Misconduct serious enough to warrant discharge is not necessarily serious enough to warrant a denial of job insurance benefits. Such misconduct must be "substantial." When based on carelessness, the carelessness must actually indicate a "wrongful intent" to be disqualifying in nature. <u>Newman v.</u> lowa Department of Job Service, 351 N.W.2d 806 (lowa App. 1984). Poor work performance is

not misconduct in the absence of evidence of intent. <u>Miller v. Employment Appeal Board</u>, 423 N.W.2d 211 (Iowa App. 1988).

While claimant could have been more proactive about reading the packet and asking questions, employer told her to have her doctor sign the packet and return it without more detail about when it was due or any further obligation of claimant. Claimant made a good-faith effort to comply with employer's request and employer's failure to be more specific or set a deadline for claimant does not establish misconduct on the part of claimant. Benefits are allowed.

### **DECISION:**

The February 18, 2004, reference 01, decision is affirmed. Claimant was discharged from employment for no disqualifying reason. Benefits are allowed, provided claimant is otherwise eligible.
