STATEMENT OF THE CASE:

On May 5, 2022, Cutty Bell (claimant) filed a timely appeal from the April 28, 2022 (reference 02) decision that held the claimant was overpaid \$1,254.00 for three weeks between March 20, 2022 and April 9, 2022, due to the April 15, 2022 (reference 01) decision that disqualified the claimant in connection with an able and available determination. After due notice was issued, a hearing was held on June 17, 2022. Claimant participated. The hearing in this matter was consolidated with the hearing in Appeal Number 22A-UI-11440-JT-T. Exhibit A, the online appeal, was received into evidence. The administrative law judge took official notice of the following Agency administrative records: the reference 01 and 02 decisions, DBRO, KCCO, WAGE C, and the reference 01 fact-finding materials.

ISSUE:

Whether the claimant was overpaid \$1,254.00 for three weeks between March 20, 2022 and April 9, 2022, due to the April 15, 2022 (reference 01) decision that disqualified the claimant in connection with an able and available determination.

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

Cutty Bell (claimant) established a new benefit year that was effective March 20, 2022. Iowa Workforce Development set the weekly benefit amount at \$418.00. The claimant received \$1,254.00 in benefits for three weeks between March 20, 2022 and April 9, 2022.

On April 15, 2022, Iowa Workforce Development Benefits Bureau issued a reference 01 decision that denied benefits effective March 20, 2022, based on the deputy's conclusion the claimant was not partially unemployed within the meaning of the law. The reference 01 decision prompted and is the basis for the overpayment decision from which the claimant appeals in the present matter. The reference 01 decision has been affirmed in Appeal Number 22A-UI-11440-JT-T.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.3(7) provides, in pertinent part:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

Because the reference 01 decision denied benefits effective March 20, 2022, and because the reference 01 decision remains in effect, the \$1,254.00 in benefits the claimant received for three weeks between March 20, 2022 and April 9, 2022 is an overpayment of benefits. The claimant must repay the overpaid benefits.

DECISION:

The April 28, 2022 (reference 02) decision is affirmed. The claimant was overpaid \$1,254.00 in benefits for three weeks between March 20, 2022 and April 9, 2022, due to the April 15, 2022 (reference 01) decision that disqualified the claimant for benefits effective March 20, 2022.

REMAND:

Pursuant to the remand in Appeal Number 22A-UI-11440-JT-T, this matter is REMANDED to the Investigations & Recovery Unit for determination of whether the claimant is subject to penalties under lowa Code sections 96.16(4) and 96.5(8) and (13) in connection with the overpaid benefits at issue in this matter.

- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
