# **STATEMENT OF THE CASE:**

The claimant Pat Schellsmidt appealed a representative's decision dated February 21, 2024, (reference 03) that concluded the claimant was overpaid unemployment insurance benefits as a result of a disqualification decision. The parties were properly notified of the hearing. A telephone hearing was scheduled to be held on March 27, 2024. After reviewing the file, the administrative law judge was able to make a determination without holding a hearing.

#### ISSUE:

The issue is whether the claimant is overpaid unemployment insurance benefits.

#### FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Iowa Workforce Development (IWD) issued a January 31, 2024 (reference 01) decision finding claimant ineligible for benefits effective January 21, 2024, because he failed to participate in a because he failed to report as directed for a reemployment and eligibility assessment. Claimant filed for and received regular state unemployment insurance benefits in the gross amount of \$756.00 for the two-week period ending February 3, 2024.

After the overpayment decision was issued IWD issued a subsequent decision dated March 14, 2024, (reference 04) that found claimant had participated in the assessment and allowed benefits effective January 21, 2024, the same date of the initial disqualification.

### **REASONING AND CONCLUSIONS OF LAW:**

For the following reasons the administrative law judge concludes the claimant was not overpaid unemployment insurance benefits.

Iowa Code § 96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.

a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

There is no decision in effect at this time that finds claimant ineligible for benefits. The administrative law judge concludes that claimant has not been overpaid unemployment insurance benefits in the amount of \$756.00, pursuant to lowa Code § 96.3(7), as IWD issued a subsequent decision dated March 14, 2024, (reference 04) allowing claimant benefits effective January 21, 2024.

## **DECISION:**

The February 21, 2024 (reference 03) unemployment insurance decision is reversed. Claimant was not overpaid unemployment insurance benefits of \$756.00 for two weeks from January 21, 2024 through February 3, 2024, as the underlying disqualifying decision that led to an initial overpayment adjudication has since been resolved in claimant's favor in the reference 04 decision.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
