ADMINISTRATIVE LAW JUDGE DECISION

US WATER SERVICES CORPORATION Employer

Iowa Code § 96.3(5) – Benefit Duration - Business Closing Iowa Admin. Code r. 871-24.29(1) and (2) – Business Closing

## STATEMENT OF THE CASE:

On May 13, 2024, claimant Christina E. Shepherd filed a timely appeal from the May 9, 204, (reference 01) unemployment insurance decision that denied the request to redetermine the claim based upon a business closure. After due notice was issued, a telephone conference hearing was held at 8:00 a.m. on Thursday, May 30, 2024. Claimant Christina E. Shepherd personally participated. Employer US Water Services Corporation participated through Jamee Haines, HR Director. Claimant's Exhibit A was received and admitted into the record.

### **ISSUE:**

Is the claimant eligible to have IWD recalculate the monetary determination due to business closing?

### FINDINGS OF FACT:

Having heard the testimony and having reviewed the evidence in the record, the administrative law judge finds: Claimant worked for the US Water Services Corporation as a lead wastewater operator, running the wastewater plant for the City of Grimes. She was laid off from employment on April 12, 2024, after the wastewater plant was decommissioned. The City of Grimes ("Grimes") decided to contract with the City of Des Moines to process its wastewater, so it no longer needed to operate its own wastewater facility. Grimes continues to operate its own water plant, but wastewater is processed differently. It requires different equipment and the workers who process it need different certifications. Now that the wastewater plant has been decommissioned, there is no further wastewater processing work in Grimes.

### **REASONING AND CONCLUSIONS OF LAW:**

The administrative law judge concludes that the claimant was laid off as a result of a business closure at the location where she worked. Claimant is entitled to a redetermination of wage credits.

lowa Code § 96.3(5)a provides:

The maximum total amount of benefits payable to an eligible individual during a benefit year shall not exceed the total of the wage credits accrued to the individual's account during the individual's base period, or sixteen times the individual's weekly benefit amount, whichever is the lesser. The director shall maintain a separate account for each individual who earns wages in insured work. The director shall compute wage credits for each individual by crediting the individual's account with one-third of the wages for insured work paid to the individual during the individual's base period. However, the director shall recompute wage credits for an individual who is laid off due to the individual's employer going out of business at the factory, establishment, or other premises at which the individual was last employed, by crediting the individual's account with one-half, instead of one-third, of the wages for insured work paid to the individual during the individual's base period. Benefits paid to an eligible individual shall be charged against the base period wage credits in the individual's account which have not been previously charged, in the inverse chronological order as the wages on which the wage credits are based were paid. However if the state "off indicator" is in effect and if the individual is laid off due to the individual's employer going out of business at the factory, establishment, or other premises at which the individual was last employed, the maximum benefits payable shall be extended to twenty-six times the individual's weekly benefit amount, but not to exceed the total of the wage credits accrued to the individual's account. (Emphasis added.)

Iowa Admin. Code r. 871-24.29(1) provides:

Whenever an employer at a factory, establishment, or other premises goes out of business at which the individual was last employed and is laid off, the individual's account is credited with one-half, instead of one-third, of the wages for insured work paid to the individual during the individual's base period, which may increase the maximum benefit amount up to 26 times the weekly benefit amount or one-half of the total base period wages, whichever is less...

Iowa Admin. Code r. 871-24.29(2) provides:

Going out of business means any factory, establishment, or other premises of an employer which closes its door and ceases to function as a business; however, an employer is not considered to have gone out of business at the factory, establishment, or other premises in any case in which the employer sells or otherwise transfers the business to another employer, and the successor employer continues to operate the business.

The wastewater plant where claimant worked has been decommissioned. The parties agree there is no further work available in wastewater processing at the location in Grimes. Based on this evidence, I conclude the employer did close the business and claimant is eligible to have her monetary determination recalculated.

## **DECISION:**

The May 9, 2024, (reference 01) unemployment insurance decision is reversed. The claimant was laid off due to a business closure. Claimant's monetary determination should be recalculated due to the business closure.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

1) The name, address, and social security number of the claimant.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
