Section 96.5-2-a – Prior Adjudication of a Discharge Separation

STATEMENT OF THE CASE:

Teri Hanesford (claimant) appealed a representative's February 11, 2004 decision (reference 03) that concluded her separation from work with Cedar Falls Lodging (employer) had been previously adjudicated as a disqualifying discharge from employment. After hearing notices were mailed to the parties' last-known addresses of record, a telephone hearing was held on March 3, 2004. The claimant participated personally. The employer participated by Julie Haler, General Manager.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds that: The January 7, 2004, separation from the employer was adjudicated in a February 5, 2004, reference 01, decision.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code Section 96.5-2-a provides:

An individual shall be disqualified for benefits:

- 2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:
- a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

Insomuch as the January 7, 2004, separation from the employer was adjudicated in the February 5, 2004, reference 01, decision, the administrative law judge does not have jurisdiction to address that issue.

DECISION:

The representative's February 11, 2004 decision (reference 03) is affirmed. The January 7, 2004, separation at issue has been previously adjudicated.
