STATEMENT OF THE CASE:

Crystal K Gottsch, the claimant/appellant,¹ appealed the Iowa Workforce Development (IWD) October 13, 2023, (reference 12) unemployment insurance (UI) decision. IWD denied Ms. Gottsch REGULAR (state) UI benefits as of October 8, 2023 because IWD concluded that IWD mailed her a notice to report to IWD for an appointment, but she did not do so. On October 26, 2023, the Iowa Department of Inspections, Appeals, and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing to Ms. Gottsch for a telephone hearing scheduled for November 8, 2023.

The undersigned administrative law judge held a telephone hearing on November 8, 2023. The undersigned heard Appeals 23A-UI-10055-DZ-T, 23A-UI-10056-DZ-T, and 23A-UI-10057-DZ-T together and created one hearing record. Ms. Gottsch participated in the hearing personally. The undersigned took official notice of the administrative record.

ISSUES:

Is Ms. Gottsch able to and available for work as of October 8, 2023? Did Ms. Gottsch fail to report to IWD as directed by an IWD representative or offer justifiable cause for not doing so?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the undersigned finds: Ms. Gottsch filed her initial UI claim effective March 26, 2023. Ms. Gottsch never received a letter from IWD about an appointment. The administrative record (Alfresco and CID) does not contain any letter from IWD to Ms. Gottsch about an appointment.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes Ms. Gottsch is eligible for UI benefits as of October 8, 2023.

Iowa Code section 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-24.2(1)e provides:

- e. In order to maintain continuing eligibility for benefits during any continuous period of unemployment, an individual shall report as directed to do so by an authorized representative of the department. If the individual has moved to another locality, the individual may register and report in person at a workforce development center at the time previously specified for the reporting.
- (1) An individual who files a weekly continued claim will have the benefit payment automatically deposited weekly on a debit card specified by the department.
- (2) The department retains the ultimate authority to choose the method of reporting and payment.

Iowa Admin. Code r. 871-24.23(11) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(11) Failure to report as directed to workforce development in response to the notice which was mailed to the claimant will result in the claimant being deemed not to meet the availability requirements.

UI rules require a claimant to participate in reemployment services unless the claimant shows justifiable cause for not doing so, or the claimant has previously completed the training or services.² If a claimant does not participate in the services without justifiable cause, the claimant is disqualified from receipt of UI benefits until the claimant participates in the services.³ Justifiable cause includes an important and significant reason that a reasonable person would consider adequate justification in view of the importance of reemployment to the claimant. Not

participating in the services or not showing justifiable cause means the claimant is not available for work.⁴

In this case, Ms. Gottsch never received a letter from IWD telling her about an appointment. Ms. Gottsch is eligible for UI benefits as of October 8, 2023.

DECISION:

The October 13, 2023 (reference 12) decision is REVERSED. Ms. Gottsch never received a letter from IWD about an appointment, and she is able to and available for work as of October 8, 2023. Ms. Gottsch is eligible for UI benefits as of October 8, 2023.

APPEAL RIGHTS. If you disagree with this decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
