STATEMENT OF THE CASE:

On May 13, 2022, Ms. Nicole Young f/k/a Nicole Young-Beal, claimant/appellant, appealed from the February 23, 2022, (reference 02) unemployment insurance decision that found claimant was overpaid \$318.00 in regular unemployment benefits for 1 week between April 11-17, 2021, due to the reference 01 decision that denied benefits as of 04/11/21 for not being able and available for work. Notices of hearing were mailed to the parties last known addresses of record for a telephone hearing scheduled for July 1, 2022, at 2:00PM. The Department did not participate. Claimant personally participated. The following hearings were held together as part of a consolidated hearing: Appeals 22A-UI-12473-DH-T; 22A-UI-12474-DH-T; and 22A-UI-12477-DH-T. Judicial notice was taken of the administrative record, DBRO and DBIN.

ISSUES:

Is claimant's appeal timely?
Was claimant overpaid benefits?

FINDINGS OF FACT:

Having heard the testimony and reviewed the evidence in the record, the undersigned finds:

Claimant's appeal is dated 05/13/22. To be timely, the appeal needed to be filed on or before 03/07/22, the first nonholiday weekday ten days after the mailing date. The decision was mailed to claimant's last known addresses on 02/23/22. Claimant did not receive this decision. Claimant became aware of the issue when she received a statement letter advising her of the total amount of overpayment she owed. Claimant received this in either March or April of 2022 and decided the amount was low enough that instead of appealing, she paid the overpayments.

July 1, 2022, at 1:00PM, 22A-UI-12472-DH-T was held, and the appeal was dismissed as untimely filed, keeping in place the underlying decision (reference 01) that denied benefits as of 04/11/21 due to claimant not being able and available for work.

Claimant filed a claim for unemployment benefits with an original claim date of 04/11/21. Claimant's weekly benefit amount (WBA) was \$318.00. The record shows claimant was paid \$318.00 in regular unemployment benefits for the 1 week between April 11-17, 2021. Claimant does not dispute this.

REASONING AND CONCLUSIONS OF LAW:

The first issue to be considered in this appeal is whether the appellant's appeal is timely. The administrative law judge determines it is not timely.

Iowa Code § 96.6(2) provides, in pertinent part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:

(a) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.

(b) If transmitted via the State Identification Data Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.

(c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information/ or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The ten calendar days for appeal begins running on the mailing date. The "decision date" found in the upper right-hand portion of the representative's decision, unless otherwise corrected immediately below that entry, is presumptive evidence of the date of mailing. *Gaskins v. Unempl. Comp. Bd. of Rev.*, 429 A.2d 138 (Pa. Comm. 1981); *Johnson v. Board of Adjustment*, 239 N.W.2d 873, 92 A.L.R.3d 304 (Iowa 1976).

The record in this case shows that more than ten calendar days elapsed between the mailing date and the date this appeal was filed. The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. Iowa Dep't of Job Serv.*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. Iowa Dep't of Job Serv.*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott*, 319 N.W.2d 244, 247 (Iowa 1982). The question in this case thus becomes whether the appellant was deprived of a reasonable opportunity to assert an appeal in a timely fashion. *Hendren v. Iowa Emp't Sec. Comm'n*, 217 N.W.2d 255 (Iowa 1974); *Smith v. Iowa Emp't Sec. Comm'n*, 212 N.W.2d 471, 472 (Iowa 1973).


Claimant did not have an opportunity to appeal the fact-finder's decision because the decision was not received. Without notice of a disqualification, no meaningful opportunity for appeal exists. See *Smith v. Iowa Employment Security Commission*, 212 N.W.2d 471, 472 (Iowa 1973).

Claimant learned of the disqualification from an IWD letter notifying claimant of the total amount of monies owed due to the overpayments. This letter was received sometime in April or May 2022. Claimant decided to pay the overpayment, as opposed to appeal, since the dollar amount was relatively low. The appeal dated May 13, 2022, was attached to this matter. Depending upon when the overpayment statement was received, claimant took anywhere from 13 days (if received May 31, 2022) to 73 days (if received April 1, 2022) to submit the appeal. This is beyond ten days. There was no good cause reason established for the delay, and in fact claimant did not intent to appeal this matter, as she paid off the overpayments. Claimant's appeal dated 05/13/22 is not filed on time. The administrative law judge lacks jurisdiction (authority) to decide the other issues in this matter.

Claimant provided an updated last name during the hearing, advising she is no longer Ms. Young-Beal, but now Ms. Young. Claimant is directed to contact IWD customer service at 1-866-239-0843 to update their contact information so it can be updated within all of IWD's systems.

DECISION:

The February 23, 2022, (reference 02) unemployment insurance decision that found claimant was overpaid \$318.00 in regular unemployment benefits, remains in effect as the appeal is untimely and the appeal is **DISMISSED**.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
