871 IAC 26.8(1) – Withdrawal of Appeal

STATEMENT OF THE CASE:

The claimant filed a timely appeal from an unemployment insurance decision dated May 12, 2004, reference 05, which denied benefits for the week ending April 24, 2004. Due notice was issued for a telephone hearing to be held June 10, 2004. At the time of the hearing, the claimant requested that the appeal be withdrawn.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: The claimant, the appellant in this matter, has requested that the appeal be withdrawn.

REASONING AND CONCLUSIONS OF LAW:

A rule found 871 IAC 26.8(1) allows the administrative law judge to grant an appellant's request for the withdrawal of its appeal. A review of all matters of record persuades the administrative law judge that it is appropriate to allow the withdrawal of this appeal.

DECISION:

The unemployment insurance decision dated May 12, 2004, reference 05, remains in effect. The claimant is ineligible for unemployment insurance benefits for the week ending April 24, 2004.
