**STATEMENT OF THE CASE:**

On May 23, 2022, the claimant filed an appeal from the unemployment insurance decision dated April 15, 2022, Reference 01 that denied benefits. Notice of hearing was mailed to the parties' last known addresses of record for a telephone hearing to be held at 2:00 p.m. on June 3, 2022, at Des Moines, Iowa. The claimant participated personally. The employer participated through Devin Collins, Senior Manager for Walmart Unemployment Services. Claimant's Exhibit 1 was admitted to the record. The administrative law judge took official notice of the administrative record.

**ISSUES:**

Is the claimant able to and available for work?  
Is the claimant still employed at the same hours and wages?  
Is the claimant totally, partially, or temporarily unemployed?  
Is the employer's account subject to charge?

**FINDINGS OF FACT:**

The claimant has worked full-time for this employer since July of 1988. He is currently a Quality Assurance Clerk and reports to Terri Carter. He received a notice of layoff in March 2022, and was laid off from work for one week, with a return date of March 29, 2022. The employer does not dispute the layoff, and the claimant provided the notice of layoff for the record.

**REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes the claimant is still employed at the same wages and hours but was temporarily unemployed during the week in question. He was able and available for work during that week. Benefits are allowed.

Iowa Code section 96.4(3)a provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. a. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.1A, subsection 37, paragraph "b", subparagraph (1), or temporarily unemployed as defined in section 96.1A, subsection 37, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Here, the employer acknowledged that the claimant was laid off for the week in question. The claimant was able and available for work and is eligible for benefits for the one week between March 22, 2022 and March 29, 2022.

**DECISION:**

The April 15, 2022, Reference 01 unemployment insurance decision denying benefits is REVERSED. The claimant is eligible for benefits for the one week between March 22, 2022 and March 29, 2022.

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday. *There is no filing fee to file an appeal with the Employment Appeal Board.*

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may file a petition for judicial review in district court.

2. If you do not file an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at [www.iowacourts.gov/efile](http://www.iowacourts.gov/efile). *There may be a filing fee to file the petition in District Court.*

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

**DERECHOS DE APELACIÓN.** Si no está de acuerdo con la decisión, usted o cualquier parte interesada puede:

Una decisión de la Junta de Apelaciones de Empleo es una acción final de la agencia. Si una de las partes no está de acuerdo con la decisión de la Junta de Apelación de Empleo, puede presentar una petición de revisión judicial en el tribunal de distrito.

2. Si no presenta una apelación de la decisión del juez ante la Junta de Apelación de Empleo dentro de los quince (15) días, la decisión se convierte en una acción final de la agencia y tiene la opción de presentar una petición de revisión judicial en el Tribunal de Distrito dentro de los treinta (30) días.
