STATEMENT OF THE CASE:

Claimant filed an appeal from the August 24, 2020, (reference 01) decision that denied benefits. After due notice was issued, a hearing was held on September 14, 2022. The claimant did participate. The employer did participate through Barbara Meeker. Employer's Exhibits 1-2 were admitted to the record.

ISSUES:

Whether the appeal is timely?

Whether claimant is still employed at the same hours and wages?

Whether claimant is eligible to receive partial benefits?

Whether claimant is able and available for work?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: A decision was mailed to the claimant's last known address of record on August 24, 2020. The decision contained a warning that an appeal must be postmarked or received by the Appeals Section by September 3, 2020. The appeal was not filed until August 13, 2022, which is after the date noticed on the disqualification decision. Claimant stated that she did receive this decision and the reference 02 decision that appears to be a repeat of this decision. Claimant stated that she tried to contact someone at IWD. (No record shows of any attempt to contact an individual at IWD at or around the time of these decisions).

Claimant worked as a full time residential specialist for employer. She continued to work in this position throughout the time that she was filing for benefits. Claimant would take partial weeks

off from work as sick weeks, but at all times work was available for claimant when she chose to come in to work, and at all times claimant continued to be employed as a full time residential specialist, whether or not she chose or was able to work full time hours.

Employer reported pay to claimant that was far different than claimant's reported pay. Employer's reported pay for claimant would have eliminated claimant from eligibility from unemployment benefits for nearly every week that she received benefits and would have also removed claimant from eligibility to receive PUA benefits. This is because claimant's weekly benefit amount is \$518.00, and claimant's weekly benefit amount plus \$15.00 is \$533.00. Claimant's income for the great majority of weeks when she filed for benefits appears to have been well above this amount.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.6(2) provides, in pertinent part:

The representative shall promptly examine the claim and any protest, take the initiative to ascertain relevant information concerning the claim, and, on the basis of the facts found by the representative, shall determine whether or not the claim is valid, the week with respect to which benefits shall commence, the weekly benefit amount payable and its maximum duration, and whether any disqualification shall be imposed. . . . Unless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision.

The ten calendar days for appeal begin running on the mailing date. The "decision date" found in the upper right-hand portion of the representative's decision, unless otherwise corrected immediately below that entry, is presumptive evidence of the date of mailing. *Gaskins v. Unempl. Comp. Bd. of Rev.*, 429 A.2d 138 (Pa. Comm. 1981); *Johnson v. Board of Adjustment*, 239 N.W.2d 873, 92 A.L.R.3d 304 (Iowa 1976).

Pursuant to rules Iowa Admin. Code r. 871-26.2(96)(1) and Iowa Admin. Code r. 871-24.35(96)(1), appeals are considered filed when postmarked, if mailed. *Messina v. IDJS*, 341 N.W.2d 52 (Iowa 1983).

The record in this case shows that more than ten calendar days elapsed between the mailing date and the date this appeal was filed. The lowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott*, 319 N.W.2d 244, 247 (Iowa 1982). The question in this case thus becomes whether the appellant was deprived of a reasonable opportunity to assert an appeal in a timely fashion. *Hendren v. IESC*, 217 N.W.2d 255 (Iowa 1974); *Smith v. IESC*, 212 N.W.2d 471, 472 (Iowa 1973). The record shows that the appellant did have a reasonable opportunity to file a timely appeal.

The administrative law judge concludes that failure to file a timely appeal within the time prescribed by the Iowa Employment Security Law was not due to any Agency error or misinformation or delay or other action of the United States Postal Service pursuant to Iowa

Admin. Code r. 871-24.35(2). The administrative law judge further concludes that the appeal was not timely filed pursuant to Iowa Code Section 96.6-2, and the administrative law judge lacks jurisdiction to make a determination with respect to the nature of the appeal. See, *Beardslee v. IDJS*, 276 N.W.2d 373 (Iowa 1979) and *Franklin v. IDJS*, 277 N.W.2d 877 (Iowa 1979).

This matter will be remanded to the benefits bureau as it appears that claimant's wages throughout the time when she received both regular and PUA benefits would have made her ineligible for the receipt of either regular of PUA benefits. Both appear to have been granted to her.

DECISION:

The August 24, 2020, (reference 01) decision is affirmed. The appeal in this case was not timely, and the decision of the representative remains in effect.

This matter will be remanded to the benefits bureau as it appears that claimant's wages throughout the time when she received both regular and PUA benefits would have made her ineligible for the receipt of either regular of PUA benefits.

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may file a petition for judicial review in district court.

2. If you do not file an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at www.iowacourts.gov/efile. There may be a filing fee to file the petition in District Court.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
