STATEMENT OF THE CASE:

On April 12, 2022, Alaytra Westmark, claimant/appellant, appealed from the February 25, 2021, (reference 01) unemployment insurance decision that denied benefits from 03/15/20 through 05/30/20 since claimant was working enough hours to be considered employed. Notices of hearing were mailed to the parties' last known addresses of record for a telephone hearing scheduled for May 27, 2022, at 11:00AM. Employer, Dubuque Community School District, participated through Mindy Klien, payroll specialist. Claimant personally participated. The following hearings were held together as part of a consolidated hearing: Appeals 22A-UI-09236-DH-T; 22A-UI-09237-DH-T; 22A-UI-09238-DH-T; and 22A-UI-09239-DH-T. Judicial notice was taken of the administrative record.

ISSUES:

Is claimant's appeal timely? Is the claimant able to and available for work? Is the claimant still employed at the same hours and wages? Is the claimant totally, partially, or temporarily unemployed? Is the employer's account subject to charge?

FINDINGS OF FACT:

Having heard the testimony and reviewed the evidence in the record, the undersigned finds:

Claimant's appeal is dated April 12, 2022. To be timely, the appeal needed to be filed on or before March 8, 2021, the first nonholiday weekday ten days after the mailing date. The decision was mailed to claimant's last known addresses on February 25, 2021, which is the same address she currently uses. Claimant received the 02/25/21 decision but does not recall the exact date. Claimant remembers there was time left to submit an appeal before the deadline listed on the notice (03/07/21, a Sunday). Things were influx due to the pandemic and the employer was in

the process of deciding whether they would pay everyone regardless. If pay were approved, it would mean claimant did not need unemployment benefits. Claimant decided not to appeal the decision. The employer paid claimant to the end of May 2020.

REASONING AND CONCLUSIONS OF LAW:

The first issue to be considered in this appeal is whether the appellant's appeal is timely. The administrative law judge determines it is not timely.

lowa Code § 96.6(2) provides, in pertinent part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:

(a) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.

(b) If transmitted via the State Identification Date Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.

(c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott* 319 N.W.2d 244, 247 (Iowa 1982).

Here, the claimant received the decision in the mail and, therefore, had an opportunity to file an appeal prior to the appeal deadline. Claimant's delay was not due to an error or misinformation from the Department or due to delay or other action of the United States Postal Service. No other good cause reason has been established for the delay. Claimant made a choice to not file an appeal in this matter. Claimant's appeal dated 04/12/22 was not filed on time and the administrative law judge lacks jurisdiction (authority) to decide the other issue in this matter.

DECISION:

The February 25, 2021, (reference 01) unemployment insurance decision that denied benefits from 03/15/20 through 05/30/20 remains in effect as the appeal in this case was not timely, and the appeal is **DISMISSED**.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

1) The name, address, and social security number of the claimant.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf or by contacting the District Court Clerk of Court https://www.iowacourts.gov/iowa-courts/court-directory/.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
