STATEMENT OF THE CASE:

The Appeals Bureau docketed a Jose Troche (claimant) appeal from the Iowa Workforce Development (IWD) March 14, 2024 (reference 02) decision that allowed benefits to the claimant for the period beginning March 10, 2024, provided the claimant was otherwise eligible, based on an IWD deputy's conclusion that the claimant had during that week submitted records indicating the claimant was legally authorized to work in the United States and thereby met that aspect of the availability requirement for the period beginning March 10, 2024.

On April 9, 2024, Iowa Department of Inspections, Appeals, and Licensing (DIAL) UI Appeals Bureau mailed a notice of hearing to Mr. Troche's last known address of record for a telephone hearing set for 1:01 p.m. on April 25, 2024. Mr. Troche did not comply with the hearing notice instructions to call the toll-free number at the time of the hearing and did not participate in the appeal hearing. Spanish-English interpreter Frank (#15970) of CTS Language Link was present and available to assist with the hearing. There were three appeal numbers set for a consolidated hearing that was to start at 1:00 p.m.: 24AUI03588JTT, 24AUI03590JTT, and 24AUI03591JTT. Based upon the claimant/appellant's failure to participate in the hearing, the administrative law judge did not hold a hearing.

ISSUE:

Whether the appeal should be dismissed based on the claimant/appellant's failure to appear for and participate in the appeal hearing.

FINDINGS OF FACT:

Jose Troche (claimant) is the appellant in this matter and in two companion appeal numbers. DIAL UI Appeals Bureau properly notified the claimant/appellant of the scheduled appeal hearing. The administrative law judge and a Spanish-English interpreter were available for the hearing as scheduled. The claimant/appellant did not appear for or participate in the appeal hearing. The claimant/appellant did not request a postponement of the hearing. The claimant/appellant did not

appear before the record closed at 1:17 p.m. The administrative law judge did not hold a hearing because the claimant/appellant did not appear.

The Iowa Workforce Development (IWD) March 14, 2024 (reference 02) decision allowed benefits to the claimant for the period beginning March 10, 2024, provided the claimant was otherwise eligible, based on an IWD deputy's conclusion that the claimant had during that week submitted records indicating the claimant was legally authorized to work in the United States and thereby met that aspect of the availability requirement for the period beginning March 10, 2024.

REASONING AND CONCLUSIONS OF LAW:

The Iowa Administrative Procedures Act at Iowa Code § 17A.12(3) provides, in relevant part:

If a party fails to appear or participate in a contested case proceeding after proper service of notice, the presiding officer may, if no adjournment is granted, enter a default decision or proceed with the hearing and make a decision in the absence of the party. ... If a decision is rendered against a party who failed to appear for the hearing and the presiding officer is timely requested by that party to vacate the decision for good cause, the time for initiating a further appeal is stayed pending a determination by the presiding officer to grant or deny the request. If adequate reasons are provided showing good cause for the party's failure to appear, the presiding officer shall vacate the decision and, after proper service of notice, conduct another evidentiary hearing. If adequate reasons are not provided showing good cause for the party's failure to appear, the presiding officer shall deny the motion to vacate.

Iowa Admin. Code r. 26.14(7) provides:

If a party has not responded to a notice of telephone hearing by providing the appeals bureau with the names and telephone numbers of the persons who are participating in the hearing by the scheduled starting time of the hearing or is not available at the telephone number provided, the presiding officer may proceed with the hearing. If the appealing party fails to provide a telephone number or is unavailable for the hearing, the presiding officer may decide the appealing party is in default and dismiss the appeal as provided in Iowa Code section 17A.12(3). The record may be reopened if the absent party makes a request in writing to reopen the hearing under subrule 26.8(3) and shows good cause for reopening the hearing.

- a. If an absent party responds to the hearing notice while the hearing is in progress, the presiding officer shall pause to admit the party, summarize the hearing to that point, administer the oath, and resume the hearing.
- b. If a party responds to the notice of hearing after the record has been closed and any party which has participated is no longer on the telephone line, the presiding officer shall not take the evidence of the late party.
- c. Failure to read or follow the instructions on the notice of hearing shall not constitute good cause for reopening the record.

Due process requires notice and an opportunity to be heard, both of which were provided to the party/parties. The appellant is responsible for going forward with the case in a prompt and thoughtful manner. The hearing notice instructs the party/parties to call the toll-free number

listed on hearing notice at the time the hearing is scheduled to begin. The appellant must be present at the start of the hearing to avoid a default judgment.

The claimant/appellant did not call in for the hearing and is in default. The appeal is dismissed. The IWD unemployment insurance decision remains in effect.

DECISION:

The claimant defaulted on the appeal. The appeal is DISMISSED. The March 14, 2024 (reference 02) decision that allowed benefits for the period beginning March 10, 2024, provided the claimant was otherwise eligible, based on an IWD deputy's conclusion that the claimant had during that week submitted records indicating the claimant was legal authorized to work in the United States and thereby met that aspect of the availability requirement for the period beginning March 10, 2024, remains in effect.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf>.

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2. Si nadie presenta una apelación de la decisión del juez ante la Junta de Apelaciones Laborales dentro de los quince (15) días, la decisión se convierte en acción final de la agencia y usted tiene la opción de presentar una petición de revisión judicial en el Tribunal de Distrito dentro de los treinta (30) días después de que la decisión adquiriera firmeza.
