## STATEMENT OF THE CASE:

On May 24, 2024, Susan Lynch (claimant) filed a timely appeal from the May 14, 2024 (reference 12) decision that held the claimant was overpaid \$600.00 in Federal Pandemic Unemployment Compensation (FPUC) for two weeks between February 28, 2021 and March 27, 2021, due to a failure to report and/or incorrect report of earned wages. After due notice was issued, the appeal commenced on July 26, 2024 and concluded on August 1, 2024. Susan Lynch (claimant) participated personally and was represented by attorney Lea Kiefer of lowa Legal Aid. Attorney Jeffrey Koncsol represented lowa Workforce Development and presented testimony through Tyler Lysinger, IWD Investigator 2.

There were five appeal numbers set for a consolidated hearing: 24AUI05095JTT, 24AUI05096JTT, 24AUI05097JTT, 24AUI05098JTT, and 24AUI05099JTT.

Exhibits 1 through 16 and A through D were received into evidence.

### **ISSUES:**

Whether the claimant was overpaid \$600.00 in Federal Pandemic Unemployment Compensation (FPUC) for two weeks between February 28, 2021 and March 27, 2021.

#### FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds:

Susan Lynch (claimant) established an original claim for regular state unemployment insurance benefits that was effective March 15, 2020. Ms. Lynch made weekly claims that included weekly claims for each of the weeks between February 28, 2021 and March 27, 2021 and received Pandemic Emergency Unemployment Compensation (PEUC) benefits for the weeks that ended March 6, March 13, and March 27, 2021.

Based on the payment of PEUC benefits for the three weeks ending March 6, March 13, and March 27, 2021, IWD paid and Ms. Lynch received \$300.00 in Federal Pandemic Unemployment Compensation (FPUC) benefits for each of those three weeks. The FPUC

benefits paid for the period totaled \$900.00. See Exhibit 14, p.68. Ms. Lynch's eligibility for FPUC benefits for the particular weeks was contingent upon Ms. Lynch being eligible for regular PEUC benefits for the same week.

Ms. Lynch was ineligible for PEUC benefits for the weeks ending March 6, March 13, March 20, and March 27, 2021. The PEUC benefits Ms. Lynch received for the weeks ending March 6, March 13, and March 27, 2021 were an overpayment of benefits. The overpayment of PEUC benefits arose from Ms. Lynch's failure to report wages earned from her full-time employer, Western Dubuque Community School District. See Appeal Number 24AUI05096JTT and the May 14, 2024 (reference 10) decision.

## **REASONING AND CONCLUSIONS OF LAW:**

PL116-136, Sec. 2104 provides, in pertinent part:

- (b) Provisions of Agreement
- (1) Federal pandemic unemployment compensation.--Any agreement under this section shall provide that the State agency of the State will make payments of regular compensation to individuals in amounts and to the extent that they would be determined if the State law of the State were applied, with respect to any week for which the individual is (disregarding this section) otherwise entitled under the State law to receive regular compensation, as if such State law had been modified in a manner such that the amount of regular compensation (including dependents' allowances) payable for any week shall be equal to
  - (A) the amount determined under the State law (before the application of this paragraph), plus
  - (B) an additional amount of \$600 (in this section referred to as "Federal Pandemic Unemployment Compensation").

. . . .

- (f) Fraud and Overpayments
- (2) Repayment.--In the case of individuals who have received amounts of Federal Pandemic Unemployment Compensation to which they were not entitled, the State shall require such individuals to repay the amounts of such Federal Pandemic Unemployment Compensation to the State agency, except that the State agency may waive such repayment if it determines that—
  - (A) the payment of such Federal Pandemic Unemployment Compensation was without fault on the part of any such individual; and
  - (B) such repayment would be contrary to equity and good conscience.
- (3) Recovery by state agency
  - (A) In general.—The State agency shall recover the amount to be repaid, or any part thereof, by deductions from any Federal Pandemic Unemployment Compensation payable to such individual or from any unemployment compensation payable to such individual under any State

or Federal unemployment compensation law administered by the State agency or under any other State or Federal law administered by the State agency which provides for the payment of any assistance or allowance with respect to any week of unemployment, during the 3-year period after the date such individuals received the payment of the Federal Pandemic Unemployment Compensation to which they were not entitled, in accordance with the same procedures as apply to the recovery of overpayments of regular unemployment benefits paid by the State.

- (B) Opportunity for hearing.—No repayment shall be required, and no deduction shall be made, until a determination has been made, notice thereof and an opportunity for a fair hearing has been given to the individual, and the determination has become final.
- (4) Review.—Any determination by a State agency under this section shall be subject to review in the same manner and to the same extent as determinations under the State unemployment compensation law, and only in that manner and to that extent.

The Continued Assistance Act restored FPUC benefits at a rate of \$300.00 per week for the period beginning December 27, 2020.

Ms. Lynch was overpaid \$900.00 Federal Pandemic Unemployment Compensation (FPUC) for three weeks between February 28, 2021 and March 27, 2021. Ms. Lynch was ineligible for and overpaid PEUC benefits for the weeks ending March 6, March 13, and March 27, 2021. Because Ms. Lynch's eligibility for the FPUC benefits received for the weeks in question depended on her eligibility for PEUC benefits, Ms. Lynch was not eligible for the \$300.00 in weekly FPUC benefits that IWD paid and that Ms. Lynch received for the weeks ending March 6, March 13, and March 27, 2021. Ms. Lynch must repay the overpaid FPUC benefits unless she applies for and IWD approves waiver of repayment of FPUC benefits.

The present overpayment decision reflects the administrative law judge's consideration of the relevant and applicable law. The administrative law judge has considered claimant's counsel's several novel and creative arguments concerning the overpayment matter but finds them to be legally unsound and not requiring further analysis or response herein.

## **DECISION:**

The May 14, 2024 (reference 12) decision is MODIFIED adverse to the claimant/appellant as follows. The claimant was overpaid \$900.00 Federal Pandemic Unemployment Compensation (FPUC) for three weeks between February 28, 2021 and March 27, 2021. The claimant must repay the overpaid FPUC benefits unless she applies for and IWD approves waiver of repayment of overpaid FPUC benefits.

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

#### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at lowa Code §17A.19, which is online at https://www.legis.iowa.gov/docs/code/17A.19.pdf.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
