STATEMENT OF THE CASE

Matt L. Johnson filed an appeal of a November 30, 2012 decision (reference 05) issued by Iowa Workforce Development (IWD). In this decision, IWD determined that Mr. Johnson was ineligible to receive unemployment insurance benefits as of November 25, 2012, for failure to report for a reemployment and eligibility assessment.

The case was transmitted from IWD to the Department of Inspections and Appeals on December 17, 2012 to schedule a contested case hearing. Before a hearing could be scheduled, the undersigned administrative law judge received notification from IWD that it had vacated its decision of November 30, 2012 because Mr. Johnson participated in the required assessment. By new decision dated December 13, 2012, IWD restored unemployment insurance benefits to Mr. Johnson as of November 25, 2012.

DECISION

IWD's decision dated December 13, 2012 has made Matt L. Johnson's appeal moot as Mr. Johnson has now received the outcome sought in the appeal. Accordingly, this case shall be dismissed. IWD shall take any action necessary to implement this decision.
