Section 96.4-3 - Eligibility for Benefits

STATEMENT OF THE CASE:

Western Livestock Express, Inc. filed a timely appeal from an unemployment insurance decision dated April 28, 2004, reference 01, which allowed benefits to Douglas R. Backhaus upon a finding that he was working a reduced workweek basis. After due notice was issued, a telephone hearing was held May 24, 2004 with Mr. Backhaus participating. Safety and Compliance Administrator Andy Gates participated for the employer.

FINDINGS OF FACT:

Having heard the testimony of the witnesses and having examined all of the evidence in the record, the administrative law judge finds: Douglas R. Backhaus has been employed by

Western Livestock Express, Inc. since August 10, 2002. He normally works 40 or more hours per week. During the week of April 4 through April 10, 2004 he worked fewer hours than normal because less work was available from his employer. His gross earnings that week were less than the sum of his unemployment insurance weekly benefit amount plus \$15.00.

REASONING AND CONCLUSIONS OF LAW:

The question is whether Mr. Backhaus is eligible for unemployment insurance benefits for the week ending April 10, 2004. He is.

Iowa Code Section 96.4-3 provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph 1, or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

The statute defines a partially unemployed individual as one who works less than his regular weekly amount and earns less than the sum of his weekly benefit amount plus \$15.00 in a given week. See Iowa Code Section 96.19. The evidence in this record establishes that during the week of April 4 through April 10, 2004, Mr. Backhaus' hours and earnings were reduced because the employer did not have work available for him. Under these circumstances, Mr. Backhaus is eligible for benefits for the week in question.

DECISION:

The unemployment insurance decision dated April 28, 2004, reference 01, is modified. The claimant is eligible for unemployment insurance benefits for the week ending April 10, 2004.
