## STATEMENT OF THE CASE

Claimant James Reysack appealed decisions issued by Iowa Workforce Development (the Department) dated February 23, 2015 and February 25, 2015, disqualifying him from receiving benefits and requiring repayment of benefits received while disqualified, respectively. A telephone hearing was scheduled for March 20, 2015 on the appeals. On March 19, 2015, the Appellant provided the Department and with a request by e-mail to withdraw his appeal.

The Department's regulations permit an appeal to be withdrawn at any time prior to the issuance of a decision upon the request of the Appellant and with the approval of the presiding officer.<sup>1</sup>
