**STATEMENT OF THE CASE:**

On December 8, 2023, Casey's Marketing Company (employer) filed an appeal from the statement of charges dated November 9, 2022, reference 04, for the third quarter of 2021. A hearing was held on January 18, 2023, pursuant to due notice. Tryell M. Rush (claimant) did not respond to the hearing notice and did not participate. The employer participated through Marizeliz Ortiz, Account Executive with Valeu NSN LLC. The department's Exhibits D1 through D3 were admitted into the record. The administrative law judge took official notice of the claimant's decision record and overpayment decision.

**ISSUES:**

Was the employer's protest timely?  
Was the employer's appeal from the statement of charges timely?

**FINDINGS OF FACT:**

Having reviewed all of the evidence in the record, the administrative law judge finds: The claimant separated from employment on September 2, 2022, and filed a claim for benefits effective September 4. On September 30, following a fact-finding interview, Iowa Workforce Development (IWD) issued an unemployment insurance decision denying unemployment insurance benefits and the claimant's claim was locked. (Exhibit D3) The separation decision has not been appealed and has become final agency action. On October 24, IWD issued a decision finding the claimant had been overpaid unemployment insurance benefits, which removed the charges from the employer's account.

The employer's next notice of the claimant's claim for benefits was the receipt of the statement of charges mailed November 9 for the third quarter of 2022. (Exhibit D1) The statement of

charges, which did not mail until November, was compiled during the first week of October. On December 8, the employer filed an appeal to the statement of charges. (Exhibit D2)

### REASONING AND CONCLUSIONS OF LAW:

For the following reasons, the administrative law judge concludes the employer does not have appeal rights to the statement of charges.

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

Iowa Code section 96.7(2)a(6) provides:

2. Contribution rates based on benefit experience.

a. (6) Within forty days after the close of each calendar quarter, the department shall notify each employer of the amount of benefits charged to the employer's account during that quarter. The notification shall show the name of each individual to whom benefits were paid, the individual's social security number, and the amount of benefits paid to the individual. **An employer which has not been notified as provided in section 96.6, subsection 2, of the allowance of benefits to an individual, may within thirty days after the date of mailing of the notification appeal to the department for a hearing to determine the eligibility of the individual to receive benefits.** The appeal shall be referred to an administrative law judge for hearing and the employer and the individual shall receive notice of the time and place of the hearing. [Emphasis added.]

Iowa Admin. Code r. 871-26.4 provides, in relevant part:

2. An appeal from an initial decision concerning the allowance or denial of benefits shall be filed, by mail, facsimile, or e-mail, online, or in person, not later than ten calendar days, as determined by the postmark or the date stamp after the decision was mailed to the party at its last-known address and shall state the following:

- a. The name, address and social security number of the claimant;
- b. A reference to the decision from which appeal is taken; and,
- c. The grounds upon which the appeal is based.

3. Notwithstanding the provisions of subrule 26.4(2), a contributory employer, which has not previously received a notice of the filing of a valid claim for benefits, may appeal an individual's eligibility to receive benefits within 30 days from the mailing date of the quarterly statement of benefit charges.

4. Also notwithstanding the provisions of subrule 26.4(2), a reimbursable employer, which has not previously received a notice of the filing of a valid claim

for benefits, may appeal an individual's eligibility to receive benefits within 15 days of the mailing date of the quarterly billing of benefit charges.

Iowa Code section 96.7(2)a(6) states that a contributory employer who did not receive notice of the claim, or was not notified of the allowance of benefits, may appeal to the department following receipt of a statement of charges. In this case, the agency denied benefits to the claimant and no appeal to that decision has been filed. The employer had prior notice of the claim, but the charges are not credited to the employer's account until an overpayment decision is issued. The overpayment decision was issued after the statement of charges was created. The employer does not have appeal rights to the statement of charges.

The issue is remanded to the Tax Bureau to credit the employer's account if it has not already been done.

**DECISION:**

The November 9, 2022, reference 04, statement of charges for the third quarter of 2022 is affirmed. The employer had prior notice of the claim and does not have appeal rights to the statement of charges.

**REMAND:**

If not already done, the employer's account shall be credited the benefits paid to the claimant on a future statement of charges based on the decisions denying benefits and finding the claimant was overpaid.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

**AN APPEAL TO THE BOARD SHALL STATE CLEARLY:**

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at Iowa Code §17A.19, which is online at <https://www.legis.iowa.gov/docs/code/17A.19.pdf> or by contacting the District Court Clerk of Court <https://www.iowacourts.gov/iowa-courts/court-directory/>.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
