871 IAC 26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

The employer appealed a representative's August 5, 2013 determination (reference 01) that held the claimant qualified to receive benefits and the employer's account subject to charge because the claimant had been discharged for nondisqualifying reasons. Hearings had been scheduled on September 17 and December 3, 2013, but were continued. On December 5, 2013, the employer sent the Appeals Section a request to withdraw its appeal. Based on the employer's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The employer withdrew its appeal from a representative's August 5, 2013 determination (reference 01). The employer faxed its written withdrawal to the Appeals Section on December 5, 2013.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

- (1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

DECISION:

The representative's August 5, 2013 determination (reference 01) is affirmed. The employer's withdrawal request is approved. This means as of July 14, 2013, the claimant remains qualified to receive benefits, provided he meets all other eligibility requirements. The employer's account is subject to charge.
