Section 96.4-3 - Able and Available

STATEMENT OF THE CASE:

Claimant filed an appeal from a decision of a representative dated November 5, 2004, reference 07, which held claimant not able and available for work. After due notice, a telephone conference hearing was scheduled for and held on December 15, 2004. Claimant participated personally. Exhibit A was admitted into evidence.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant was in an outpatient rehabilitation program at Horizon through November 3, 2004. Claimant spent four hours in the morning in the program and four hours in

the evening. Claimant was also on medication for migraine headaches, which did not cause her significant disability. Claimant did not make work searches September 12, through September 18, 2004 and October 10, 2004 through October 30, 2004. Claimant normally worked afternoons and evenings in her prior employment. Claimant, while in rehabilitation, was not available for work.

REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether claimant is able and available for work.

Iowa Code Section 96.4-3 provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph 1, or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

871 IAC 24.22(1)a provides:

Benefits eligibility conditions. For an individual to be eligible to receive benefits the department must find that the individual is able to work, available for work, and earnestly and actively seeking work. The individual bears the burden of establishing that the individual is able to work, available for work, and earnestly and actively seeking work.

(1) Able to work. An individual must be physically and mentally able to work in some gainful employment, not necessarily in the individual's customary occupation, but which is engaged in by others as a means of livelihood.

a. Illness, injury or pregnancy. Each case is decided upon an individual basis, recognizing that various work opportunities present different physical requirements. A statement from a medical practitioner is considered prima facie evidence of the physical ability of the individual to perform the work required. A pregnant individual must meet the same criteria for determining ableness as do all other individuals.

871 IAC 24.23(35) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(35) Where the claimant is not able to work and is under the care of a medical practitioner and has not been released as being able to work.

Inasmuch as the illness was not work-related and the treating physician had not released the claimant to return to work, the claimant has not established the ability to work effective

September 12, 2004 through November 3, 2004 due to participation in a rehabilitation program. Claimant also failed to make adequate work searches. Claimant's prior statements given to the Workforce Development representatives are more credible than the statements at the time of hearing. As such, claimant failed to make adequate work searches and benefits shall be withheld.

DECISION:

The decision of the representative dated November 5, 2004, reference 07 is affirmed. Claimant is not eligible to receive unemployment insurance benefits, effective September 12, 2004 through September 18, 2004.
