## STATEMENT OF THE CASE:

The employer appealed the representative's decision dated March 3, 2023, (reference 01) that concluded it failed to file a timely protest regarding the claimant's separation of employment on September 12, 2021, and no disqualification of unemployment insurance benefits was imposed. A hearing was scheduled and held on March 29, 2023, pursuant to due notice. Claimant participated personally. Employer participated by hearing representative Randy Gonzalez. The administrative law judge took notice of the administrative record.

# **ISSUES:**

Whether the employer's protest is timely?

# FINDINGS OF FACT:

The administrative law judge, having considered all of the evidence in the record, finds that: The claimant's notice of claim was mailed to the employer's address of record on February 17, 2023, and received by the employer within ten days. The notice of claim contains a warning that any protest must be postmarked or returned not later than ten days from the initial mailing date. The employer did not effect a protest until March 2, 2023, which is after the ten-day period had expired.

The email name and address listed for this employee were those of the home office of the employer rather than the employer's third party unemployment provider. Employer gave no reason for this listing. Employer was emailed the Notice of Original Claim through the SOPHIA/SIDES system on February 17, 2023. The person who received the email did not forward it to the employer's 3rd party unemployment benefits provider. Employer's Edge was mailed a copy of this ref 01 decision, and their representative stated that this was the first they were alerted of the filing of a claim by claimant. The actual representative working on this fie of Employer's Edge was not present for the hearing, and neither was any representative of GCC Alliance Concrete.

Employer provided no documentation to show that IWD was notified about sending SOPHIA/ SIDES documents to the email of the third party representative rather than the employer's home

office. The representative present stated that other documents have been received by the third party representative Vis SIDES during the time claimant has been employed.

The administrative law judge notes that a SIDES search under employer's SEIN number still to this date indicates the email address as <a href="mailto:hrcenter@gcc.com">hrcenter@gcc.com</a>.

#### REASONING AND CONCLUSIONS OF LAW:

Iowa Code section 96.6(2) provides, in pertinent part:

2. Initial determination. A representative designated by the director shall promptly notify all interested parties to the claim of its filing, and the parties have ten days from the date of mailing the notice of the filing of the claim by ordinary mail to the last known address to protest payment of benefits to the claimant.

A portion of the Iowa Code section dealing with timeliness of an appeal from a representative's decision states that such an appeal must be filed within ten days after notification of that decision was mailed. In addressing an issue of timeliness of an appeal under that portion of this Code section, the Iowa Supreme Court held that this statute prescribing the time for notice of appeal clearly limits the time to do so, and that compliance with the appeal notice provision is mandatory and jurisdictional. *Beardslee v. IDJS*, 276 N.W.2d 373 (lowa 1979).

The administrative law judge considers the reasoning and holding of that court in that decision to be controlling on this portion of that same lowa Code section which deals with a time limit in which to file a protest after notification of the filing of the claim has been mailed. The employer has not shown any good cause for not complying with the jurisdictional time limit. The third party representative's statements are not in accordance with information contained in the SIDES system – namely that the ongoing email address for employer through this system is not an Employer's Edge email address, but rather an email address for the employer's office. Therefore, the administrative law judge is without jurisdiction to entertain any protest regarding the separation from employment.

The administrative law judge concludes the employer failed to effect a timely protest within the time period prescribed by the lowa Employment Security Law, and the delay was not due to any Agency error or misinformation or delay or other action of the United States Postal Service pursuant to Iowa Admin. Code r. 871-24.35(2). Any error in this matter appears to be on the part of communication between employer and their third party representative – either on creating the appropriate email address to send documents, or in forwarding the information to the third party representative. The administrative law judge further concludes that the employer has failed to effect a timely protest pursuant to Iowa Code § 96.6-2, and the administrative law judge lacks jurisdiction to make a determination with respect to the nature of the claimant's termination of employment. See *Beardslee v. IDJS*, 276 N.W.2d 373 (Iowa 1979); *Franklin v. IDJS*, 277 N.W.2d 877 (Iowa 1979) and *Pepsi-Cola Bottling Company v. Employment Appeal Board*, 465 N.W.2d 674 (Iowa App. 1990).

# **DECISION:**

The decision of the representative dated March 3, 2023, (reference 01) is affirmed. The employer has failed to file a timely protest, and the decision of the representative shall stand and remain in full force and effect.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday. There is no filing fee to file an appeal with the Employment Appeal Board.

## AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may file a petition for judicial review in district court.

2. If you do not file an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at <a href="https://www.iowacourts.gov/efile">www.iowacourts.gov/efile</a>. There may be a filing fee to file the petition in District Court.

**Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
