**STATEMENT OF THE CASE:**

Kosi-Kuma M. Amenyido (claimant) filed a timely appeal from the June 7, 2018, reference 06 unemployment insurance decision that denied benefits because of a failure to report as directed. After due notice was issued, a telephone conference hearing was held on June 28, 2018. The claimant participated. Official notice was taken of the administrative record, specifically the claimant's appeal letter.

**ISSUE:**

Did the claimant fail to report as directed or offer a good cause reason for failure to do so?

**FINDINGS OF FACT:**

Having heard the testimony and having examined the evidence in the record, the administrative law judge finds: On May 24, 2018, a notice was mailed to the claimant to be available for a call from IWD about his availability for work the week ending May 19, 2018. The claimant received the notice but did not answer the call because he was in class. He received the fact-finder's voice message but did not return the phone call. The claimant did not contact IWD about the issue with the week ending May 19 until the following week, on June 12.

**REASONING AND CONCLUSIONS OF LAW:**

For the reasons that follow, the administrative law judge concludes the claimant was not eligible for benefits the week of June 3 through June 9, 2018, as he failed to report as directed. Benefits are denied for that week. The claimant reported to IWD the following week and is eligible for benefits effective June 10, 2018, provided he is otherwise eligible.

Iowa Code § 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in section 96.19, subsection 38, paragraph "b", unnumbered paragraph (1), or temporarily unemployed as defined in section 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of section 96.5, subsection 3 are waived if the individual is not disqualified for benefits under section 96.5, subsection 1, paragraph "h".

Iowa Admin. Code r. 871-24.2(1)e provides:

e. In order to maintain continuing eligibility for benefits during any continuous period of unemployment, an individual shall report as directed to do so by an authorized representative of the department. If the individual has moved to another locality, the individual may register and report in person at a workforce development center at the time previously specified for the reporting.

The method of reporting shall be weekly if a voice response continued claim is filed, unless otherwise directed by an authorized representative of the department. An individual who files a voice response continued claim will have the benefit payment automatically deposited weekly in the individual's account at a financial institution or be paid by the mailing of a warrant on a biweekly basis.

In order for an individual to receive payment by direct deposit, the individual must provide the department with the appropriate bank routing code number and a checking or savings account number.

The department retains the ultimate authority to choose the method of reporting and payment.

Iowa Admin. Code r. 871-24.23(11) provides:

Availability disqualifications. The following are reasons for a claimant being disqualified for being unavailable for work.

(11) Failure to report as directed to workforce development in response to the notice which was mailed to the claimant will result in the claimant being deemed not to meet the availability requirements.

The claimant received the notice to report, but has not established a good cause reason for his failure to report the week of June 3 through June 9, 2018. Benefits are denied for that week. He reported the following week and is considered eligible for benefits effective June 10, 2018, provided he is otherwise eligible.

## **DECISION:**

The June 7, 2018, reference 06, unemployment insurance decision is modified in favor of the claimant. The claimant has not established a good cause reason for failing to report as directed

for the week of June 3 through June 9, 2018; therefore, benefits are denied that week. He did report the following week. Benefits are allowed effective June 10, 2018, provided he is otherwise eligible.
