#### STATEMENT OF THE CASE:

Mary E. Winston (claimant) appealed a representative's April 14, 2004 decision (reference 03) that denied her request to redetermine her claim as a business closing. A hearing was scheduled for May 26, 2004. Prior to the hearing, the claimant made a request to withdraw her appeal. Based on the claimant's withdrawal request, the administrative record and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The claimant made a request to withdraw this appeal. The claimant faxed her written request to withdraw or cancel her appeal. The Appeals Section received his request on May 25, 2004.

### REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The claimant's request to withdraw her appeal is approved.

#### DECISION:

The representative's April 14, 2004 decision (reference 03) is affirmed. The claimant's request to withdraw her appeal is approved. This means the claimant's request to have her claim redetermined to a business closing is denied, but the claimant remains qualified to receive unemployment insurance benefits as of November 23, 2003, provided she meets all other eligibility requirements.
