Iowa Code § 96.5(2)a – Discharge

STATEMENT OF THE CASE:

Edward Hoelscher, the claimant/appellant,¹ appealed the Iowa Workforce Development (IWD) May 16, 2024 (reference 01) unemployment insurance (UI) decision. IWD denied Mr. Hoelscher REGULAR (state) UI benefits because IWD concluded the employer discharged him from employment on April 11, 2024 for wanton carelessness while performing his job. On May 23, 2024, the Iowa Department of Inspections, Appeals, and Licensing (DIAL), UI Appeals Bureau mailed a notice of hearing to Mr. Hoelscher and the employer for a telephone hearing scheduled for June 10, 2024.

The administrative law judge held a telephone hearing on June 10, 2024. Mr. Hoelscher participated in the hearing personally. The employer did not participate in the hearing. The administrative law judge admitted Department's Exhibit 1 and Claimant's Exhibit A as evidence.

The administrative law judge concludes Mr. Hoelscher is eligible for UI benefits based on how his job ended with this employer.

ISSUE:

Did the employer discharge Mr. Hoelscher from employment for disqualifying, job-related misconduct?

FINDINGS OF FACT:

Having reviewed the evidence in the record, the administrative law judge finds: Mr. Hoelscher began working for the employer in 2022. He worked as a part-time driver. His employment ended on April 11, 2024.

On April 11, Mr. Hoelscher called in to take off the afternoon due to a septic tank issue at his home. The employer told Mr. Hoelscher that it would cover his shift. About an hour later, Mr. Hoelscher's supervisor called him and told him that the employer no longer needed his services.

¹ Claimant is the person who applied for UI benefits. Appellant is the person or employer who appealed.

The supervisor did not give Mr. Hoelscher a reason for why the employer ended his employment.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the employer discharged Mr. Hoelscher from employment on April 11, 2024 for a reason that does not disqualify him from receiving UI benefits.

Iowa Code section 96.5(2)(a) and (d) provide, in relevant part:

An individual shall be disqualified for benefits:

2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:

a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

d. For the purposes of this subsection, "misconduct" means a deliberate act or omission by an employee that constitutes a material breach of the duties and obligations arising out of the employee's contract of employment. Misconduct is limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer.

Iowa Admin. Code r. 871-24.32(4) provides:

(4) Report required. The claimant's statement and employer's statement must give detailed facts as to the specific reason for the claimant's discharge. Allegations of misconduct or dishonesty without additional evidence shall not be sufficient to result in disqualification. If the employer is unwilling to furnish available evidence to corroborate the allegation, misconduct cannot be established. In cases where a suspension or disciplinary layoff exists, the claimant is considered as discharged, and the issue of misconduct shall be resolved.

The employer has the burden of proof in establishing disqualifying job misconduct.² The issue is not whether the employer made a correct decision in separating the claimant from employment, but whether the claimant is entitled to unemployment insurance benefits.³ Misconduct must be "substantial" to warrant a denial of job insurance benefits.⁴

In an at-will employment environment an employer may discharge an employee for any number of reasons or no reason at all if it is not contrary to public policy, but if it fails to meet its burden of proof to establish job related misconduct as the reason for the separation, it incurs potential liability for unemployment insurance benefits related to that separation. A determination as to whether an employee's act is misconduct does not rest solely on the interpretation or application of the employer's policy or rule. A violation of the employer's policy or rule is not necessarily disqualifying misconduct even if the employer was fully within its rights to impose discipline up to or including discharge for the incident under its policy.

In this case, the employer did not participate in the hearing and provided no evidence of disqualifying, job-related misconduct on the part of Mr. Hoelscher. Mr. Hoelscher denies that he engaged in any misconduct. Since the employer has not established disqualifying job-related misconduct, Mr. Hoelscher is eligible for UI benefits.

DECISION:

The May 16, 2024 (reference 01) UI decision is REVERSED. The employer discharged Mr. Hoelscher from employment on April 11, 2024 for a reason that does not disqualify him from receiving UI benefits. Mr. Hoelscher is eligible for UI benefits, as long as no other decision denies him UI benefits.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
