Section 96.5-1 – Voluntary Quit

STATEMENT OF THE CASE:

Paul Redding (claimant) appealed an unemployment insurance decision dated January 29, 2004, reference 02, which held that he was not eligible for unemployment insurance benefits because he voluntarily quit his employment with Kum & Go (employer) without good cause attributable to the employer. After hearing notices were mailed to the parties' last-known addresses of record, a telephone hearing was held on February 27, 2004. The claimant participated in the hearing. The employer participated through Robin Phillips, General Manager.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds that: The claimant was employed as a full-time clerk from May 13, 2003 through August 18, 2003. He quit his employment when he walked off the job.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the reasons for the claimant's separation from employment qualify him to receive unemployment insurance benefits.

Iowa Code Section 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

The claimant voluntarily quit on August 18, 2003. The claimant has the burden of proving that the voluntary quit was for a good reason that would not disqualify him. Iowa Code Section 96.6-2. The claimant testified he just walked off the job. There is no evidence to indicate the claimant quit his employment with good cause attributable to the employer. Benefits are therefore denied.

DECISION:

The unemployment insurance decision dated January 29, 2004, reference 02, is affirmed. The claimant voluntarily left work without good cause attributable to the employer. Benefits are withheld until he has worked in and has been paid wages for insured work equal to ten times his weekly benefit amount provided he is otherwise eligible.
