871 IAC 24.7(3) – Monetary Eligibility
Section 96.23 – Base Period Exclusion

STATEMENT OF THE CASE:

Keith Stahlhut (claimant) appealed an unemployment insurance decision dated January 16, 2005, reference 01, which held that he was not eligible for unemployment insurance benefits. After hearing notices were mailed to the parties' last-known addresses of record, a telephone hearing was held on February 21, 2005. The claimant participated in the hearing. The employer did not comply with the hearing notice instructions and did not call in to provide a telephone number at which a representative could be contacted, and therefore, did not participate.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds that: The claimant filed a claim for unemployment insurance benefits effective January 16, 2005. His base period is from October 1, 2003 through September 30, 2004. He previously filed a worker's compensation claim and received temporary total disability benefits from September 10, 2003 through January 7, 2004. He received permanent partial disability benefits from January 8, 2004 through January 11, 2005.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant is monetarily eligible for unemployment insurance benefits since he had no wage records or lacks qualifying wage requirements. For the following reasons, the administrative law judge finds the claimant is not monetarily eligible.

Iowa Code Section 96.23 provides:

The department shall exclude three or more calendar quarters from an individual's base period, as defined in section 96.19, subsection 3, if the individual received workers' compensation benefits for temporary total disability or during a healing period under section 85.33, section 85.34, subsection 1, or section 85A.17 or indemnity insurance benefits during those three or more calendar quarters, if one of the following conditions applies to the individual's base period:

1. The individual did not receive wages from insured work for three calendar quarters.
2. The individual did not receive wages from insured work for two calendar quarters and did not receive wages from insured work for another calendar quarter equal to or greater than the amount required for a calendar quarter, other than the calendar quarter in which the individual's wages were highest, under section 96.4, subsection 4.

The department shall substitute, in lieu of the three or more calendar quarters excluded from the base period, those three or more consecutive calendar quarters, immediately preceding the base period, in which the individual did not receive such workers' compensation benefits or indemnity insurance benefits.

For the above mentioned code section to apply, the claimant must have received temporary total disability or healing period benefits during three or more calendar quarters of his base period. The claimant did not receive temporary total benefits for three quarters of his base period. He does not qualify for unemployment insurance benefits because he is not monetarily eligible.

DECISION:

The unemployment insurance decision dated January 16, 2005, reference 01, is affirmed. The claimant is not monetarily eligible to receive unemployment insurance benefits.
