Iowa Code § 17A.12(3) – Default Decision  
Iowa Admin. Code r. 871-26.14(7) – Dismissal of Appeal on Default

**STATEMENT OF THE CASE:**

An appeal was filed from a representative's unemployment insurance decision dated July 5, 2016, (reference 03) that concluded Archie Coulter was not eligible to receive unemployment insurance benefits as he was mailed a notice to report for a reemployment services orientation on June 28, 2016 and he did not report. The issues certified for appeal were whether the Department correctly determined the claimant is ineligible to receive unemployment insurance benefits and whether the Department correctly determined that the claimant did not establish justifiable cause for failing to participate in reemployment services. Notice of telephone hearing

was mailed to the parties' last known addresses of record on August 9, 2016, setting the hearing for 8:30 a.m. on August 30, 2016, before Administrative Law Judge Tricia A. Johnston. The notice indicated that the judge would wait five minutes after the time the hearing was scheduled to begin to allow all parties to call in. The notice further indicated that if the appellant did not call in within that time, he would not be able to participate in the hearing. At the date and time listed above, ALJ Tricia Johnston and IWD Representative Jennifer Gray appeared for hearing. At 8:35 a.m. the appellant had not appeared. After releasing Ms. Gray from the call, the undersigned kept the conferencing system open an additional five minutes. Appellant did not appear during that time. Based upon the appellant's failure to participate in the hearing and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law and decision.

**ISSUE:**

Should the appeal be dismissed based upon the appellant not participating in the hearing?

**FINDINGS OF FACT:**

The parties were properly notified of the scheduled hearing on this appeal. The appellant, Archie Coulter, did not call in to the conference call and did not participate in the hearing or request a postponement of the hearing as required by the hearing notice.

The representative's decision had concluded that Archie Coulter was not eligible to receive unemployment insurance benefits as he was mailed a notice to report for a reemployment services orientation on June 28, 2016 and he did not report. As Mr. Coulter subsequently did attend reemployment services, his claim was unlocked as of July 3, 2016. (Ref. 04).

**REASONING AND CONCLUSIONS OF LAW:**

The Iowa Administrative Procedures Act at Iowa Code § 17A.12(3) provides in pertinent part:

If a party fails to appear or participate in a contested case proceeding after proper service of notice, the presiding officer may, if no adjournment is granted, enter a default decision or proceed with the hearing and make a decision in the absence of the party. ... If a decision is rendered against a party who failed to appear for the hearing and the presiding officer is timely requested by that party to vacate the decision for good cause, the time for initiating a further appeal is stayed pending a determination by the presiding officer to grant or deny the request. If adequate reasons are provided showing good cause for the party's failure to appear, the presiding officer shall vacate the decision and,

after proper service of notice, conduct another evidentiary hearing. If adequate reasons are not provided showing good cause for the party's failure to appear, the presiding officer shall deny the motion to vacate.

The Agency rules at Iowa Admin. Code r. 871-26.14(7) provide:

If a party has not responded to a notice of telephone hearing by providing the appeals bureau with the names and telephone numbers of the persons who are participating in the hearing by the scheduled starting time of the hearing or is not available at the telephone number provided, the presiding officer may proceed with the hearing. If the appealing party fails to provide a telephone number or is unavailable for the hearing, the presiding officer may decide the appealing party is in default and dismiss the appeal as provided in Iowa Code section 17A.12(3). The record may be reopened if the absent party makes a request to reopen the hearing under subrule 26.8(3) and shows good cause for reopening the hearing.

- a. If an absent party responds to the hearing notice while the hearing is in progress, the presiding officer shall pause to admit the party, summarize the hearing to that point, administer the oath, and resume the hearing.
- b. If a party responds to the notice of hearing after the record has been closed and any party which has participated is no longer on the telephone line, the presiding officer shall not take the evidence of the late party. Instead, the presiding officer shall inquire ex parte as to why the party was late in responding to the notice of hearing. For good cause shown, the presiding officer shall reopen the record and cause further notice of hearing to be issued to all parties of record. The record shall not be reopened if the presiding officer does not find good cause for the party's late response to the notice of hearing.
- c. Failure to read or follow the instructions on the notice of hearing shall not constitute good cause for reopening the record.

The appellant appealed the representative's decision but failed to participate in the hearing. The appellant has therefore defaulted on his appeal pursuant to Iowa Code §17A.12(3) and Iowa Admin. Code r. 871-24.14(7), and the representative's decision remains in force and effect.

#### **DECISION:**

The representative's unemployment insurance decision (reference 03) dated July 5, 2016, is affirmed. The Department's determination remains in effect that Archie Coulter was not eligible to receive unemployment insurance benefits as he was mailed a notice to report for a reemployment and eligibility assessment on January 28, 2016 and he did not report. As Mr. Coulter subsequently did attend reemployment services, his claim was unlocked as of July 3, 2016. (Ref. 04).
