Section 96.3-7 – Recovery of Overpayments

STATEMENT OF THE CASE:

Jamaal R. Clarkson filed a timely appeal from an unemployment insurance decision dated March 29, 2004 reference 04 which ruled that he had been overpaid in the gross amount of \$293.00 for the week ending March 13, 2004 because of an earlier decision holding him ineligible for unemployment insurance benefits. Due notice was issued for a telephone hearing to be held April 20, 2004. Mr. Clarkson did not respond to the hearing notice. The administrative law judge takes official notice of agency benefit payment records and decision records.

FINDINGS OF FACT:

Having examined all matters of record, the administrative law judge finds: Jamaal R. Clarkson received unemployment insurance benefits in the gross amount of \$293.00 for the week ending March 13, 2004. The decision holding him ineligible for those benefits has been affirmed by the administrative law judge's decision 04A-UI-03600-AT. The agency withheld benefits for the week ending March 20, 2004 to offset the overpayment. Mr. Clarkson owes nothing to the agency at this time.

REASONING AND CONCLUSIONS OF LAW:

The question is whether Mr. Clarkson was overpaid. The evidence establishes that he received benefits for the week ending March 13, 2004 although he was not eligible for benefits for that week. According to Iowa Code Section 96.3-7 those benefits most be recovered. Agency benefit payment records establish that the benefits have been recovered. Mr. Clarkson owes nothing to the agency at this time.

DECISION:

The unemployment insurance decision dated March 29, 2004 reference 04 is affirmed. The claimant was overpaid by \$293.00 for the week ending March 13, 2004. The overpayment has been recovered.
