STATEMENT OF THE CASE:

The claimant/appellant filed an appeal from the September 30, 2021 (reference 02) unemployment insurance decision that found claimant was overpaid regular unemployment benefits funded by the State of lowa in the amount of \$669.00 for three weeks between November 8, 2020 and November 28, 2020. The claimant was properly notified of the hearing. A telephone hearing was held on November 22, 2021. The claimant participated personally. The administrative law judge took administrative notice of the claimant's unemployment insurance benefits records.

ISSUE:

Is the claimant overpaid regular unemployment insurance benefits funded by the State of lowa?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant filed an original claim for regular unemployment insurance benefits funded by the State of lowa with an effective date of April 26, 2020. Her established weekly benefit amount was \$334.00. She was paid regular unemployment insurance benefits funded by the State of lowa from November 8, 2020 through November 28, 2020 in the total amount of \$669.00.

lowa Workforce Development issued a decision dated July 23, 2021 (reference 02), which was appealed and an Administrative Law Judge (ALJ) decision was issued on September 23, 2021 by ALJ Smith stating that the claimant was not able to and available for work from November 8, 2020 through November 28, 2020. See Appeal No. 21A-UI-16647-CS-T. No further appeal of that ALJ decision was filed and it became final.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes as follows:

lowa Code § 96.3(7)a provides:

- 7. Recovery of overpayment of benefits.
- a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

In this case, the claimant received regular unemployment insurance benefits funded by the State of lowa from November 8, 2020 through November 28, 2020 but was not eligible for those benefits due to a disqualifying decision issued by ALJ Smith on September 23, 2021. See Appeal No. 21A-UI-16647-CS-T. No further appeal of that ALJ decision was filed and it became final. As such, the claimant has been overpaid unemployment insurance benefits funded by the State of lowa in the amount of \$669.00 for three weeks between November 8, 2020 and November 28, 2020.

DECISION:

The September 30, 2021 (reference 02) unemployment insurance decision is affirmed. The claimant was overpaid regular unemployment insurance benefits funded by the State of lowa in the amount of \$669.00 for three weeks between November 8, 2020 and November 28, 2020.
