871IAC26.8(1) - Withdrawal of Appeal

Claimant Joy E. Williams appealed two representative's decision. The first, dated April 16, 2010, reference 02 held she was not eligible to receive unemployment insurance benefits for the week of April 11, 2010 because she did not establish justifiable cause for failing to participate in reemployment services. The second, dated April 26, 2010, reference 03, held that Williams was not entitled to receive unemployment insurance benefits from April 11, 2010 until she reported to her local Workforce Development Center for reemployment services.

A telephone hearing was scheduled for October 25, 2010. At the time of the hearing, Sandy Krough appeared on behalf of Iowa Workforce Development and testified that, in spite of the decisions at issue, Ms. Williams eventually received the full dollar amount of unemployment insurance benefits available to her. Upon hearing this testimony, Ms. Williams requested she be allowed to withdraw her appeals. The request was made on the record in accordance with 871 IAC 26.8(1).

Claimant Joy E. Williams no longer wishes to pursue these appeals and her request to withdraw should therefore be granted.

DECISION

The decisions of Iowa Workforce Development dated, April 16, 2010, reference 02, and April 26, 2010, reference 03, are **AFFIRMED**. The request of Joy E. Williams to withdraw her appeals is approved, and the decisions of the representative shall remain in full force and effect.
