871 IAC 26.8(1) – Withdrawal of Appeal

STATEMENT OF THE CASE:

The claimant filed a timely appeal from an unemployment insurance decision dated March 11, 2004, reference 01, which disqualified him for benefits. Before a final hearing could be scheduled, the claimant requested that the appeal be withdrawn.

FINDINGS OF FACT:
