Section 96.4-3 – Able to and Available for Work

STATEMENT OF THE CASE:

Thomas N. Wisneski (claimant) appealed a representative's July 14, 2006 decision (reference 01) that concluded he was not eligible to receive benefits for the week ending June 24 because he was unavailable to work the majority of the week. After hearing notices were mailed to the parties' last-known addresses of record, a telephone hearing was held on July 31, 2006. The claimant failed to respond to the hearing notice by contacting the Appeals Section prior to the hearing and providing the phone number at which he could be contacted to participate in the hearing. As a result, no one represented the claimant. B. J. Butler appeared on Express Services, Inc. (employer's) behalf. Based on the evidence, the arguments of the employer and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law and decision.

ISSUE:

Is the claimant available to work the majority of the week ending June 24, 2006?

FINDINGS OF FACT:

The claimant registered to work on behalf of the employer in July 2005. On June 20, 2006, the claimant contacted the employer to report he was not available to work until June 26, 2006. The employer assigned the claimant to a job assignment on June 27, 2006.

The claimant filed a claim for the week ending June 24, 2006.

REASONING AND CONCLUSIONS OF LAW:

Each week a claimant files a claim for benefits, he must be able to and available for work. Iowa Code section 96.4-3. During the week ending June 24, the claimant informed the employer he was not available to work five days, June 20 through 24. Since the claimant was not available to work a majority of the week ending June 24, the claimant is not eligible to receive benefits for this week.

DECISION:

The representative's July 14, 2006 decision (reference 01) is affirmed. The claimant is not eligible to receive unemployment insurance benefits for the week ending June 24, 2006, because he was not available to work the majority of the week.
