871 IAC 24.2(1)e - Failure to Report as Directed

STATEMENT OF THE CASE:

Nancy Sisco (claimant) appealed a representative's December 29, 2003 decision (reference 02) that concluded she had failed to respond to a call-in notice and was, therefore, not eligible to receive unemployment insurance benefits. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on January 29, 2004. The claimant did participate.

FINDINGS OF FACT:

The administrative law judge, having considered all of the evidence in the record, finds that: The Agency mailed a notice to report to the claimant on December 9, 2003, which stated that the claimant's failure to respond to the notice within ten days would result in her disqualification for benefits. The claimant did not receive the call-in notice. On January 7, 2004, the claimant discovered that a notice had been sent and reported to Agency to answer all questions.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant failed to report as directed. For the following reasons the administrative law judge concludes she did.

871 IAC 24.2(1)e provides:

e. In order to maintain continuing eligibility for benefits during any continuous period of unemployment, an individual shall report as directed to do so by an authorized representative of the department. If the individual has moved to another locality, the individual may register and report in person at a workforce development center at the time previously specified for the reporting.

The method of reporting shall be weekly if a voice response continued claim is filed, unless otherwise directed by an authorized representative of the department. An individual who files a voice response continued claim will have the benefit payment automatically deposited weekly in the individual's financial institution's account or be paid by the mailing of a warrant on a biweekly basis.

In order for an individual to receive payment by direct deposit, the individual must provide the department with the appropriate bank routing code number and a checking or savings account number.

The department retains the ultimate authority to choose the method of reporting and payment.

The claimant was directed to report to the Agency within ten days of December 9, 2003. The claimant did not report to the Agency because she did not receive the notice. When a claimant does not report as directed by a call-in notice, she will not be qualified to receive benefits. The claimant reported to the Agency as soon as she discovered the notice. The claimant is eligible to receive unemployment insurance benefits.

DECISION:

The representative's December 29, 2003 decision (reference 02) is reversed. The claimant is eligible to receive unemployment insurance benefits.
