#### STATEMENT OF THE CASE:

Boston Window Cleaning, Inc. (employer) appealed a representative's March 19, 2004 decision (reference 01) that concluded Colleen A. O'Connor (claimant) was qualified to receive unemployment insurance benefits, and the employer's account was subject to charge because the claimant was temporarily unemployed or on a layoff in November. A hearing was scheduled for April 21, 2004. Prior to the hearing, the employer made a request to withdraw its appeal. Based on the employer's withdrawal request and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

# FINDINGS OF FACT:

The employer's representative, Personnel Planners, Inc., submitted a written request on April 20, 2004, to withdraw the employer's appeal in this matter.

# REASONING AND CONCLUSIONS OF LAW:

# 871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

#### DECISION:

The representative's March 19, 2004 decision (reference 01) is affirmed. The employer's request to withdraw its appeal is approved. The claimant is qualified to receive unemployment insurance benefits as of November 23, 2003, provided she meets all other eligibility requirements. The employer's account may be charged for benefits paid to the claimant.
