STATEMENT OF THE CASE:

On February 23, 2024, the employer filed an appeal from the February 13, 2024, (reference 03) unemployment insurance decision that allowed benefits based on the determination that claimant was discharged from employment without a showing of disqualifying misconduct. The parties were properly notified about the hearing. A telephone hearing was held on March 20, 2024. Claimant, Justin T. Perry, participated. Employer, Bemis Company Inc., participated through HR Generalist Amanda Massey. Employer's Exhibits 1 through 3 were admitted. The administrative law judge took official notice of the administrative record.

ISSUES:

Was the claimant discharged for disqualifying job-related misconduct? Has the claimant been overpaid unemployment insurance benefits, and if so, can the repayment of those benefits to the agency be waived? Can charges to the employer's account be waived?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant began working for employer most recently on September 27, 2023. Claimant last worked as a full-time press operator, reporting to Jim Volmeer. Claimant was separated from employment on December 20, 2023, when he was discharged.

On December 20, 2023, claimant was changing some parts on his machine. He was cleaning out the pads, when he noticed that he did not have enough pads. He went to the next machine to inquire with the operators there whether he could take some pads. While he was doing this, Volmeer came through and saw claimant. He approached claimant and began cursing at him. He asked, "What the fuck are you all standing around for?" After repeating this question, he

then said, "You need to get your ass back to fucking work." Claimant became angry. He flipped Volmeer off and told him, "Fuck you." When Volmeer asked him whether he had seen the hand gesture correctly, claimant admitted that he had flipped Volmeer off. Then, Volmeer came up to claimant and was bumping into him saying, "You want to do this?" over and over. Claimant told him to get away from him and that he needed a minute. Volmeer told claimant to come to his office. Claimant refused because he was so upset. He did eventually speak with Volmeer and a union representative. Volmeer told claimant to go home for the day and he would decide how to handle any discipline soon. That same day, Massey contacted claimant and informed him that he was being discharged for violation of the employer's operations philosophy and its anti-harassment policy. Claimant had not received any disciplinary warnings for anything similar to the final incident in the past.

The administrative record indicates that claimant filed a claim for unemployment insurance benefits with an effective date of December 24, 2023. His weekly benefit amount is \$582.00. He filed weekly continuing claims between December 24, 2023, and February 24, 2024. He received unemployment insurance benefits in the total amount of \$5,238.00. The employer did not participate in the fact-finding interview.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes that claimant was discharged from employment for no disqualifying reason.

lowa Code section 96.5(2)(a) and (d) provide:

An individual shall be *disqualified for benefits:*

2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:

a. The disqualification shall continue until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

d. For the purposes of this subsection, "*misconduct*" means a deliberate act or omission by an employee that constitutes a material breach of the duties and obligations arising out of the employee's contract of employment. Misconduct is limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or even design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. Misconduct by an individual includes but is not limited to all of the following:

(1) Material falsification of the individual's employment application.

(2) Knowing violation of a reasonable and uniformly enforced rule of an employer.

(3) Intentional damage of an employer's property.

(4) Consumption of alcohol, illegal or nonprescribed prescription drugs, or an impairing substance in a manner not directed by the manufacturer, or a combination of such substances, on the employer's premises in violation of the employer's employment policies.

(5) Reporting to work under the influence of alcohol, illegal or nonprescribed prescription drugs, or an impairing substance in an off-label manner, or a combination of such substances, on the employer's premises in violation of the employer's employment policies, unless the individual is compelled to work by the employer outside of scheduled or on-call working hours.

(6) Conduct that substantially and unjustifiably endangers the personal safety of coworkers or the general public.

(7) Incarceration for an act for which one could reasonably expect to be incarcerated that results in missing work.

(8) Incarceration as a result of a misdemeanor or felony conviction by a court of competent jurisdiction.

(9) Excessive unexcused tardiness or absenteeism.

(10) Falsification of any work-related report, task, or job that could expose the employer or coworkers to legal liability or sanction for violation of health or safety laws.

(11) Failure to maintain any license, registration, or certification that is reasonably required by the employer or by law, or that is a functional requirement to perform the individual's regular job duties, unless the failure is not within the control of the individual.

(12) Conduct that is libelous or slanderous toward an employer or an employee of the employer if such conduct is not protected under state or federal law.

(13) Theft of an employer or coworker's funds or property.

(14) Intentional misrepresentation of time worked or work carried out that results in the individual receiving unearned wages or unearned benefits.

The employer has the burden of proof in establishing disqualifying job misconduct. *Cosper v. lowa Dep't of Job Serv.*, 321 N.W.2d 6 (lowa 1982).

A determination as to whether an employee's act is misconduct does not rest solely on the interpretation or application of the employer's policy or rule. A violation is not necessarily disqualifying misconduct even if the employer was fully within its rights to impose discipline up to or including discharge for the incident under its policy. The issue is not whether the employer made a correct decision in separating claimant, but whether the claimant is entitled to unemployment insurance benefits. *Infante v. Iowa Dep't of Job Serv.*, 364 N.W.2d 262 (Iowa Ct. App. 1984). What constitutes misconduct justifying termination of an employee and what

misconduct warrants denial of unemployment insurance benefits are two separate decisions. *Pierce v. Iowa Dep't of Job Serv.*, 425 N.W.2d 679 (Iowa Ct. App. 1988). Misconduct serious enough to warrant discharge is not necessarily serious enough to warrant a denial of job insurance benefits. Such misconduct must be "substantial." *Newman v. Iowa Dep't of Job Serv.*, 351 N.W.2d 806 (Iowa Ct. App. 1984). The focus is on deliberate, intentional, or culpable acts by the employee.

The decision in this case rests, at least in part, on the credibility of the witnesses. It is the duty of the administrative law judge as the trier of fact in this case, to determine the credibility of witnesses, weigh the evidence and decide the facts in issue. *Arndt v. City of LeClaire*, 728 N.W.2d 389, 394–95 (Iowa 2007). The administrative law judge may believe all, part or none of any witness's testimony. *State v. Holtz*, 548 N.W.2d 162, 163 (Iowa App. 1996). In assessing the credibility of witnesses, the administrative law judge should consider the evidence using his or her own observations, common sense and experience. *Id.* In determining the facts, and deciding what testimony to believe, the fact finder may consider the following factors: whether the testimony is reasonable and consistent with other believable evidence; whether a witness has made inconsistent statements; the witness's appearance, conduct, age, intelligence, memory and knowledge of the facts; and the witness's interest in the trial, their motive, candor, bias and prejudice. *Id.*

After assessing the credibility of the witnesses who testified during the hearing, reviewing the exhibits submitted by the parties, considering the applicable factors listed above, and using her own common sense and experience, the administrative law judge finds the claimant's version of events to be more credible than the employer's recollection of those events. Claimant was the only person present at the hearing that had first-hand knowledge of the final incident. Additionally, the employer acknowledged that claimant's supervisor had also been separated from employment after this incident. This lends credibility to claimant's willingness to admit to his own role in the conduct also lends credibility to his assertions that Volmeer was the aggressor and was the one to suggest that physical violence might occur.

It is true that some of claimant's conduct could, under other circumstances, constitute disqualifying misconduct without prior warning. However, he was credible when he asserted that he was not the aggressor, and that he had been taunted into anger by his supervisor. He was also credible when he denied that he had threatened physical violence. Because of these considerations, and because claimant attempted to remove himself from the situation, the administrative law judge concludes that claimant's separation was not the result of disqualifying misconduct.

Because the separation is not disqualifying, the issues of overpayment, repayment, and participation are moot.

DECISION:

The February 13, 2024, (reference 03) unemployment insurance decision is AFFIRMED. Claimant was discharged from employment for no disqualifying reason. Benefits are allowed, provided claimant is otherwise eligible. The issues of overpayment, repayment, and participation are moot.

1) The name, address, and social security number of the claimant.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final.
