DECISION

The Claimant appealed this case to the Employment Appeal Board. The members of the Employment Appeal Board reviewed the entire record. The Appeal Board, one member dissenting, finds it cannot affirm the administrative law judge's decision. The Employment Appeal Board **REVERSES** as set forth below.

FINDINGS OF FACT:

A representative issued a decision dated January 28, 2008 that concluded the Claimant was disqualified to receive benefits. The Claimant appealed that decision and in appeal 08A-UI-02536 the Administrative Law Judge affirmed based on a finding that the appeal was untimely. The Administrative Law Judge issued a separate decision in case 08A-UI-02537 finding an overpayment of \$314.00. The Claimant timely appealed the Administrative Law Judge's disqualification decision. In a concurrently issued decision in case 08A-UI-02536 the Board today finds the appeal to the Administrative Law Judge timely and thus reverses and remands the Administrative Law Judge's disqualification decision. The Board now in this decision reverses the overpayment decision.

REASONING AND CONCLUSIONS OF LAW:

Iowa Code Section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment. If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The Board concludes that the Claimant has not been overpaid unemployment insurance benefits in the amount of \$314.00 pursuant to Iowa Code section 96.3-7 as the disqualification decision that created the overpayment decision has now been reversed.

DECISION:

The administrative law judge's decision dated April 7, 2008 is **REVERSED**. The Employment Appeal Board concludes, at this time, that the Claimant was not overpaid benefits. If, on remand in the disqualification case, the Administrative Law Judge concludes that the Claimant should be disqualified then a new overpayment may be imposed at that time.
