## **STATEMENT OF THE CASE:**

On May 16, 2022, Ms. Patricia Evans, claimant/appellant, appealed the May 3, 2022, (reference 05) decision that denied benefits as of 04/10/22 due to not reporting to Iowa Workforce Development (IWD) as directed, making you not available for work. Due notice was sent to claimant for a hearing scheduled to be held by telephone conference call on July 1, 2022, at 8:00AM. Claimant personally participated. The department did not participate. The notice of hearing was defective in that the notice had dropped the "1)" regarding IAC R. 871-24.23(11). Claimant waived the defect in the notice and the appeal proceeded. The following hearings were held together as part of a consolidated hearing: Appeals 22A-UI-12488-DH-T; and 22A-UI-12489-DH-T. Judicial notice was taken of the administrative record.

## **ISSUES:**

Is the appeal timely?
Is claimant able to and available for work?
Did claimant fail to report as directed by a department representative?

#### FINDINGS OF FACT:

Having heard the testimony and considered the evidence in the record, the undersigned finds:

Claimant's appeal is dated May 16, 2022. To be timely, the appeal needed to be filed on or before May 13, 2022 (the first nonholiday, weekday, that is ten days after the decision was mailed). The decision was mailed to claimant's last known addresses on May 3, 2022, which is the same address she currently uses as of the date of the appeal hearing. Claimant received the decision on May 10, 2022. Claimant advised the reason she waited until May 16, 2022, to submit her appeal was she had been calling the person she was supposed to report to by having a telephone call for approximately one month and was hoping they would call her back. Claimant could have filed her appeal in addition to trying to contact the person with IWD, but decided to wait for a call back, eventually deciding to appeal when she talked to someone at IWD who told her if she was

wanting to appeal to not wait. No one from IWD had told her to wait as that was a decision claimant made on her own.

## **REASONING AND CONCLUSIONS OF LAW:**

The first issue to be considered in this appeal is whether the appellant's appeal is timely. The administrative law judge determines it is not timely.

lowa Code § 96.6(2) provides, in pertinent part: "[u]nless the claimant or other interested party, after notification or within ten calendar days after notification was mailed to the claimant's last known address, files an appeal from the decision, the decision is final and benefits shall be paid or denied in accordance with the decision."

Iowa Admin. Code r. 871-24.35(1) provides:

- 1. Except as otherwise provided by statute or by division rule, any payment, appeal, application, request, notice, objection, petition, report or other information or document submitted to the division shall be considered received by and filed with the division:
- (a) If transmitted via the United States Postal Service on the date it is mailed as shown by the postmark, or in the absence of a postmark the postage meter mark of the envelope in which it is received; or if not postmarked or postage meter marked or if the mark is illegible, on the date entered on the document as the date of completion.
- (b) If transmitted via the State Identification Date Exchange System (SIDES), maintained by the United States Department of Labor, on the date it was submitted to SIDES.
- (c) If transmitted by any means other than [United States Postal Service or the State Identification Data Exchange System (SIDES)], on the date it is received by the division.

Iowa Admin. Code r. 871-24.35(2) provides:

2. The submission of any payment, appeal, application, request, notice, objection, petition, report or other information or document not within the specified statutory or regulatory period shall be considered timely if it is established to the satisfaction of the division that the delay in submission was due to division error or misinformation or to delay or other action of the United States postal service.

The Iowa Supreme Court has declared that there is a mandatory duty to file appeals from representatives' decisions within the time allotted by statute, and that the administrative law judge has no authority to change the decision of a representative if a timely appeal is not filed. *Franklin v. IDJS*, 277 N.W.2d 877, 881 (Iowa 1979). Compliance with appeal notice provisions is jurisdictional unless the facts of a case show that the notice was invalid. *Beardslee v. IDJS*, 276 N.W.2d 373, 377 (Iowa 1979); see also *In re Appeal of Elliott* 319 N.W.2d 244, 247 (Iowa 1982).

Here, claimant received the decision in the mail on 05/10/22. This is before the deadline. Claimant therefore had an opportunity to file an appeal prior to the appeal deadline. Claimant's

delay was not due to an error or misinformation from the Department or due to delay or other action of the United States Postal Service. There was no good cause reason established for the delay. Claimant's reason for waiting to appeal (wanted a phone call back from IWD) was her choice. It was IWD who told her if she was going to appeal to stop waiting. Claimant's appeal date of 05/16/22 is not timely. Claimant failed to meet their burden of proof to establish their appeal was timely. Since the appeal is untimely, the administrative law judge lacks jurisdiction (authority) to decide the other issues in this matter.

## **DECISION:**

The May 3, 2022, (reference 05) unemployment insurance decision denying benefits as of 04/10/22 due to not reporting to IWD as directed, making claimant not able and available, remains in effect and the appeal is **DISMISSED** as the appeal was untimely filed.

**APPEAL RIGHTS.** If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

#### AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. **Note to Parties:** YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

**Note to Claimant:** It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.
