Iowa Code § 96.3(7) – Recovery of Benefit Overpayment

STATEMENT OF THE CASE:

The claimant appealed the June 22, 2018, (reference 06) unemployment insurance decision that concluded the claimant was overpaid unemployment insurance benefits in the amount of \$501.00 for the three-week period ending June 16, 2018, as a result of a disqualification decision. A telephone hearing was scheduled and held on July 17, 2018, pursuant to due notice. The claimant participated personally and through an interpreter with CTS Language Link.

ISSUE:

Is the claimant overpaid benefits?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant received benefits in the amount of \$501.00 for the three weeks ending June 16, 2018. Claimant was later found to have been disqualified from receiving the benefits. That decision was reversed in Appeal Number 18A-UI-07005-CL-T.

REASONING AND CONCLUSIONS OF LAW:

The administrative law judge concludes claimant has not been overpaid benefits.

Iowa Code § 96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.

a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the

overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

b. (1) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding § 96.8, subsection 5. . . .

The administrative law judge concludes that the claimant has not been overpaid unemployment insurance benefits in the amount of \$501.00, pursuant to Iowa Code § 96.3(7), as the disqualification decision that created the overpayment decision has been reversed.

DECISION:

The June 22, 2018, (reference 06) unemployment insurance decision is reversed. The claimant has not been overpaid unemployment insurance benefits in the amount of \$501.00.
