Section 96.5-2-a – Discharge for Misconduct

STATEMENT OF THE CASE:

Claimant filed an appeal from a decision of a representative dated January 10, 2005, reference 01, which held claimant ineligible for unemployment insurance benefits. After due notice, a telephone conference hearing was scheduled for and held on February 7, 2005. Claimant participated personally. Employer participated by Dianne Pethoud, Manager and represented by Anna Marie Gonzalez, Hearing Representative Employer's Unity.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on December 18, 2004.

Employer discharged claimant on December 18, 2004 because claimant failed to call in or show up for work. Claimant had just been warned about tardiness. Claimant was not told that her job was in jeopardy. Claimant missed work because she overslept. Claimant spoke to the employer and asked for time off for a funeral December 20, 2004. Employer refused to grant leave due to the funeral. Claimant turned in her uniforms because she was not granted leave to go to the funeral. Employer did not tell claimant to come in on her next scheduled shift but accepted the uniforms. If claimant had not left she would have been fired due to the funeral leave.

REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether claimant was discharged for misconduct.

Iowa Code section 96.5-2-a provides:

An individual shall be disqualified for benefits:

- 2. Discharge for misconduct. If the department finds that the individual has been discharged for misconduct in connection with the individual's employment:
- a. The individual shall be disqualified for benefits until the individual has worked in and has been paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

871 IAC 24.32(1)a provides:

Discharge for misconduct.

- (1) Definition.
- a. "Misconduct" is defined as a deliberate act or omission by a worker which constitutes a material breach of the duties and obligations arising out of such worker's contract of employment. Misconduct as the term is used in the disqualification provision as being limited to conduct evincing such willful or wanton disregard of an employer's interest as is found in deliberate violation or disregard of standards of behavior which the employer has the right to expect of employees, or in carelessness or negligence of such degree of recurrence as to manifest equal culpability, wrongful intent or evil design, or to show an intentional and substantial disregard of the employer's interests or of the employee's duties and obligations to the employer. On the other hand mere inefficiency, unsatisfactory conduct, failure in good performance as the result of inability or incapacity, inadvertencies or ordinary negligence in isolated instances, or good faith errors in judgment or discretion are not to be deemed misconduct within the meaning of the statute.

This definition has been accepted by the Iowa Supreme Court as accurately reflecting the intent of the legislature. <u>Huntoon v. Iowa Department of Job Service</u>, 275 N.W.2d 445, 448 (Iowa 1979).

871 IAC 24.32(8) provides:

(8) Past acts of misconduct. While past acts and warnings can be used to determine the magnitude of a current act of misconduct, a discharge for misconduct cannot be based on such past act or acts. The termination of employment must be based on a current act.

In this matter, the evidence failed to establish that claimant was discharged for an act of misconduct when claimant violated employer's policy concerning absenteeism. Claimant was not warned concerning this policy.

The last incident, which brought about the discharge fails to constitute misconduct because claimant was not warned concerning her tardiness and absenteeism. Claimant had a counseling session but it did not amount to a warning. This detracts from a finding of intentional conduct. The separation occurred because claimant needed funeral leave and employer would not grant such. This is an excusable reason for an absence. Employer did not discharge claimant for the absence of December 18, 2004. It was the funeral leave request that brought about the separation. Employer's denial of the leave and failure to tell claimant to report for work indicates a discharge. Absenteeism because of a funeral is excusable. Benefits allowed. The administrative law judge holds that claimant was not discharged for an act of misconduct and, as such, is not disqualified for the receipt of unemployment insurance benefits.

DECISION:

The decision of the representative dated January 10, 2005, reference 01, is reversed. Claimant is eligible to receive unemployment insurance benefits, provided claimant meets all other eligibility requirements.
