STATEMENT OF THE CASE:

An appeal was filed from the representative's decision dated May 29, 2018 (reference 03) that found claimant was not eligible for unemployment insurance benefits because he failed to report for a reemployment and eligibility assessment. A hearing was scheduled for June 29, 2018. Prior to the hearing being held, the appellant requested the appeal be withdrawn.

ISSUE:

Should the request to withdraw the appeal be granted?

FINDINGS OF FACT:

The administrative law judge, having considered the evidence in the record, finds that:

A request has been made by the appealing party to withdraw the appeal. The request has been submitted in writing to the Appeals Bureau on June 13, 2018. The hearing scheduled for June 29, 2018 at 10:00 a.m. is cancelled.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the request to withdraw the appeal is granted.

Iowa Admin. Code r. 871-26.8(1) provides:

Withdrawals, dismissals, and postponements.

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of an administrative law judge or the manager or chief administrative law judge of the appeals bureau. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer. An appeal may be dismissed upon the request of a party or in the

agency's discretion when the issue or issues on appeal have been resolved in the appellant's favor.

The appellant has made a request in writing to withdraw the appeal. The administrative law judge has reviewed the record herein and concludes that the request of the appealing party to withdraw the appeal should be approved. The hearing scheduled for June 29, 2018 at 10:00 a.m. is cancelled.

DECISION:

The decision of the representative dated May 29, 2018 (reference 03) is affirmed. The request of the appealing party to withdraw the appeal is approved, and the decision of the representative shall stand and remain in full force and effect. The hearing scheduled for June 29, 2018 at 10:00 a.m. is cancelled.
