871 IAC 26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

Djula Kajtezovic (claimant) appealed a representative's August 18, 2005 decision (reference 01) that concluded she was not qualified to receive unemployment insurance benefits and the account of Beef Products, Inc. (employer) would not be charged because the claimant had been discharged for disqualifying reasons. A hearing was scheduled for September 8, 2005. Prior to the hearing, the claimant made a request to withdraw her appeal. Based on the claimant's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The claimant made a verbal request on September 7, 2005 to withdraw her appeal. The claimant withdrew her appeal because she has another job and has not received any benefits. The claimant's September 7 withdrawal request was tape-recorded.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The claimant's request to withdraw her appeal is approved.

DECISION:

The representative's August 18, 2005 decision (reference 01) is affirmed. The claimant's request to withdraw her appeal is approved. This means the claimant remains disqualified from receiving unemployment insurance benefits as of July 24, 2005. This disqualification continues until she has been paid ten times her weekly benefit amount for insured work, provided she is otherwise eligible. The employer's account will not be charged.
