Section 96.16-4 - Misrepresentation Section 96.3-7 - Recovery of Overpayments

STATEMENT OF THE CASE:

The claimant filed an appeal from an Iowa Workforce Development decision dated March 20, 2006, reference 02, which held that the claimant was overpaid unemployment benefits in the amount of \$735.46, because he failed to report wages earned with Rinderknecht Associates for the 3-weeks ending August 6, 2005.

After due notice was issued, a hearing was scheduled for a telephone conference call on April 24,

2006. The claimant did not participate. Neil Anderson, Investigator, participated for Iowa Workforce Development, Investigation and Recovery.

# FINDINGS OF FACT:

The administrative law judge, having heard the testimony of the witness, and having examined all of the evidence in the record, finds: The claimant filed a claim for unemployment benefits with an effective date of January 2, 2005. The claimant claimed for and received unemployment benefits during the third quarter of 2005.

The department audited the claimant's unemployment claim for the second and third quarter of 2005, and Rinderknecht Associates reported to the department the gross earnings paid to the claimant during the period from July 17, 2005 to August 6, 2005. The department compared the employer's wage report against the claimant's claims for the same weeks.

The claimant reported no work and earnings for the 3-weeks ending August 6, 2005, and he received benefits of \$246, \$243.46 and \$246 for these weeks. Rinderknecht reported the claimant had earnings of \$517, \$686 and \$704 for the 3-weeks. Based on the employer's wage report the claimant was not entitled to any benefit for the 3-weeks that causes an overpayment of \$735.46.

Investigator Anderson mailed an audit notice to the claimant dated March 1, 2006 regarding the overpayment, but the claimant did not respond. Anderson concluded the claimant misrepresented his claim by failing to report his work and wages for each of the 3-weeks at issue.

The claimant failed to respond to the hearing notice.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant is overpaid benefits \$735.46, and if so whether it is the result of misrepresentation.

## Iowa Code Section 96.16-4 provides:

4. Misrepresentation. An individual who, by reason of the nondisclosure or misrepresentation by the individual or by another of a material fact, has received any sum as benefits under this chapter while any conditions for the receipt of benefits imposed by this chapter were not fulfilled in the individual's case, or while the individual was disqualified from receiving benefits, shall, in the discretion of the department, either be liable to have the sum deducted from any future benefits payable to the individual under this chapter or shall be liable to repay to the department for the unemployment compensation fund, a sum equal to the amount so received by the individual. If the department seeks to recover the amount of the benefits by having the individual pay to the department a sum equal to that amount, the department may file a lien with the county recorder in favor of the state on the individual's property and rights to property, whether real or personal. The amount of the lien shall be collected in a manner similar to the provisions for the collection of past-due contributions in section 96.14, subsection 3.

# Iowa Code Section 96.3-7 provides:

7. Recovery of overpayment of benefits. If an individual receives benefits for which

the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The division of job service in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the division a sum equal to the overpayment.

If the division determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The administrative law judge concludes that the claimant is overpaid benefits \$735.46 for the 3-weeks ending August 6, 2005 pursuant to Iowa Code section 96.16-4. The claimant misrepresented his claim by failing to report his work and wages when claiming for unemployment benefits.

# DECISION:

The decision of the representative dated March 20, 2006, reference 02, is AFFIRMED. The claimant is overpaid benefits \$735.46 due to misrepresentation.
