STATEMENT OF THE CASE:

On October 5, 2023, the employer/appellant filed an appeal from the October 2, 2023, (reference 02) unemployment insurance decision that allowed benefits beginning August 13, 2023. The Iowa Workforce development representative determined claimant is still employed part-time or working on-call whenever work is available. The representative determined claimant is available for her regular hours of work and is considered able and available for work. The parties were properly notified about the hearing. A telephone hearing was held on October 19, 2023. Claimant did not call in to participate. Employer participated through Human Resources Supervisor, Nick Krein. Employer's exhibit 1 was admitted into the record.

ISSUES:

- I. Is the claimant able to work and available for work?
- II. Is the claimant partially, totally, or temporarily unemployed?
- III. Is the claimant an on-call worker?
- IV. Is claimant employed for the same hours and wages?
- V. Is the employer's account subject to charge?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant began working for employer on June 27, 2022. Claimant was originally hired as a full-time production assembler. On or about May 14, 2023, claimant's hours were reduced to a lack of work. From August 11, 2023, through September 5, 2023, claimant had no work available.

Claimant returned to work September 6, 2023. Claimant was separated from the employer on September 15, 2023.

Claimant filed for benefits the week beginning May 14, 2023 through September 9, 2023. The employer does not dispute the weekly claims for benefits from May 14, 2023, through September 9, 2023. The employer disputes any claims for benefits after September 15, 2023.

REASONING AND CONCLUSIONS OF LAW:

For the reasons that follow, the administrative law judge concludes the claimant is partially, temporarily, or totally unemployed effective May 14, 2023 through September 9, 2023.

Iowa Code § 96.4(3) provides:

An unemployed individual shall be eligible to receive benefits with respect to any week only if the department finds that:

3. The individual is able to work, is available for work, and is earnestly and actively seeking work. This subsection is waived if the individual is deemed partially unemployed, while employed at the individual's regular job, as defined in § 96.19, subsection 38, paragraph "b", subparagraph 1, or temporarily unemployed as defined in § 96.19, subsection 38, paragraph "c". The work search requirements of this subsection and the disqualification requirement for failure to apply for, or to accept suitable work of § 96.5, subsection 3 are waived if the individual is not disqualified for benefits under § 96.5, subsection 1, paragraph "h".

Iowa Code § 96.1A(37) provides:

"Total and partial unemployment".

a. An individual shall be deemed "totally unemployed" in any week with respect to which no wages are payable to the individual and during which the individual performs no services.

b. An individual shall be deemed partially unemployed in any week in which either of the following apply:

(1) While employed at the individual's then regular job, the individual works less than the regular full-time week and in which the individual earns less than the individual's weekly benefit amount plus fifteen dollars.

(2) The individual, having been separated from the individual's regular job, earns at odd jobs less than the individual's weekly benefit amount plus fifteen dollars.

c. An individual shall be deemed temporarily unemployed if for a period, verified by the department, not to exceed four consecutive weeks, the individual is unemployed due to a plant shutdown, vacation, inventory, lack of work or emergency from the individual's regular job or trade in which the individual worked full-time and will again work full-time, if the individual's employment, although temporarily suspended, has not been terminated.

Iowa Code § 96.7(2)a(2)(a),(b), and (c) provides:

2. Contribution rates based on benefit experience.

a. (2) The amount of regular benefits plus fifty percent of the amount of extended benefits paid to an eligible individual shall be charged against the account of the employers in the base period in the inverse chronological order in which the employment of the individual occurred.

(a) However, if the individual to whom the benefits are paid is in the employ of a base period employer at the time the individual is receiving the benefits, and the individual is receiving the same employment from the employer that the individual received during the individual's base period, benefits paid to the individual shall not be charged against the account of the employer. This provision applies to both contributory and reimbursable employers, notwithstanding subparagraph (3) and § 96.8, subsection 5.

(b) An employer's account shall not be charged with benefits paid to an individual who left the work of the employer voluntarily without good cause attributable to the employer or to an individual who was discharged for misconduct in connection with the individual's employment, or to an individual who failed without good cause, either to apply for available, suitable work or to accept suitable work with that employer, but shall be charged to the unemployment compensation fund. This paragraph applies to both contributory and reimbursable employers, notwithstanding § 96.8, subsection 5.

(c) The amount of benefits paid to an individual, which is solely due to wage credits considered to be in an individual's base period due to the exclusion and substitution of calendar quarters from the individual's base period under § 96.23, shall be charged against the account of the employer responsible for paying the workers' compensation benefits for temporary total disability or during a healing period under § 85.33, § 85.34, subsection 1, or § 85A.17, or responsible for paying indemnity insurance benefits.

Beginning May 14, 2023, the claimant was not employed under the same hours and wages as contemplated at hire. Claimant was totally, temporarily, or partially unemployed since she was no longer receiving her full-time hours. The employer does not dispute claimant's eligibility for benefits from May 14, 2023, through September 9, 2023. Benefits are allowed. The employer's account shall be charged.

The issue of claimant's separation from the employer on September 15, 2023 has not been determined.

DECISION:

The October 2, 2023, (reference 02) unemployment insurance decision is modified in favor of the respondent. The claimant is partially and/or totally unemployed from May 14, 2023, through September 9, 2023. Benefits are allowed effective May 14, 2023, provided she is otherwise eligible. The employer's account shall be charged.

REMAND:

The issue of claimant's separation is remanded to Iowa Workforce Development's Benefit Bureau for an initial investigation and determination.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

2.
