481 Iowa Administrative Code (IAC) 10.24(1) – Proposed Decision Dismissing Appeal

STATEMENT OF THE CASE

On June 20, 2016, Iowa Workforce Development (IWD) issued a decision finding Brenna L. Lyons not eligible to receive unemployment insurance benefits (UIB) effective June 12, 2016 because of her alleged failure to report for a reemployment and eligibility assessment on June 16, 2016. On June 23, 2016, Lyons filed the appeal.

On July 20, 2016, IWD issued a decision reinstating UIB for Lyons effective June 12, 2016. On July 27, 2016, IWD filed a request to dismiss the appeal.

Since IWD reinstated UIB for Lyons without any break in assistance and there remains no issue left to resolve, it is ORDERED that the appeal be dismissed and the appeal hearing scheduled for August 8, 2016 be canceled. See 481 IAC 10.24(1).

DECISION

It is ORDERED that the appeal be dismissed.
