Section 96.5-1 – Voluntary Quit

STATEMENT OF THE CASE:

Employer filed an appeal from a decision of a representative dated January 21, 2004, reference 01, which held claimant eligible for unemployment insurance benefits. After due notice, a telephone conference hearing was scheduled for and held on February 16, 2004. Claimant participated. Employer participated by Tom Littlejohn, Manager.

FINDINGS OF FACT:

The administrative law judge, having heard the testimony and considered all of the evidence in the record, finds: Claimant last worked for employer on January 16, 2003. This employer gave claimant a layoff because claimant was incarcerated. The employer generally lays off at that

time of the year. Employer liked claimant and wanted to keep him on once the legal issues were resolved. Claimant was not able to come back to work due to the legal troubles until after employer had found a replacement.

REASONING AND CONCLUSIONS OF LAW:

The issue in this matter is whether claimant quit for good cause attributable to employer. The administrative law judge holds that the evidence has established that claimant voluntarily quit for good cause attributable to employer when claimant terminated the employment relationship because employer granted a layoff in an effort to preserve the employment relationship. Benefits are allowed.

Iowa Code Section 96.5-1 provides:

An individual shall be disqualified for benefits:

1. Voluntary quitting. If the individual has left work voluntarily without good cause attributable to the individual's employer, if so found by the department.

DECISION:

The decision of the representative dated January 21, 2004, reference 01, is affirmed. Unemployment insurance benefits are allowed, provided claimant is otherwise eligible.
