STATEMENT OF THE CASE:

Weststaff USA, Inc. (employer) appealed a representative's January 9, 2004 decision (reference 01) that concluded Sandra K. Walker (claimant) was qualified to receive unemployment insurance benefits, and the employer's account could be charged because the claimant had been discharged for nondisqualifying reasons. A hearing was scheduled on February 5, 2004. The claimant participated in the hearing. Mark Edwards appeared on the employer's behalf. During the hearing, the employer made a request to withdraw its appeal. Based on the employer's withdrawal request evidence, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

At the beginning of the February 5 hearing, the employer made a request to withdraw the employer's appeal. The withdrawal request was tape-recorded.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

DECISION:

The representative's January 9, 2004 decision (reference 01) is affirmed. The employer's request to withdraw its appeal is approved. The claimant is qualified to receive unemployment insurance benefits as of November 30, 2003, provided she meets all other eligibility requirements. During the claimant's current benefit year, the employer's account will not be charged.
