## STATEMENT OF THE CASE:

Claimant Ramon J. Villafana appealed a representative's decision dated April 28, 2022, (reference 04) that concluded the claimant was overpaid regular state unemployment insurance benefits and Federal Pandemic Unemployment Compensation (FPUC) as a result of a disqualification decision. After a hearing notice was mailed to the claimant's last-known address of record, a telephone hearing was held on June 23, 2022, and was consolidated with the hearing for appeals 22A-UI-11895-S2-T, 22A-UI-11896-S2-T, and 22A-UI-11898-S2-T. Claimant participated through a CTS Language Link Spanish Interpreter. The administrative law judge took official notice of the administrative record.

#### **ISSUES:**

The issue is whether the claimant is overpaid unemployment insurance benefits. The issue is whether the claimant is overpaid FPUC benefits.

#### FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: On March 4, 2022, lowa Workforce Development (IWD) issued a decision (reference 02) that denied claimant regular state unemployment insurance (UI) benefits. That decision has been affirmed. See 22A-UI-11895-S2-T. Claimant did receive benefits in the gross amount of \$10,620.00 for the twenty-six-week period ending July 31, 2021. Claimant has received FPUC benefits in the gross amount of \$5,700.00 for the nineteen-week period ending June 12, 2021.

# REASONING AND CONCLUSIONS OF LAW:

For the following reasons the administrative law judge concludes the claimant was overpaid unemployment insurance benefits and FPUC benefits.

lowa Code § 96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.

a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

PL116-136, Sec. 2104 provides, in pertinent part:

(b) Provisions of Agreement

(1) Federal pandemic unemployment compensation.--Any agreement under this section shall provide that the State agency of the State will make payments of regular compensation to individuals in amounts and to the extent that they would be determined if the State law of the State were applied, with respect to any week for which the individual is (disregarding this section) otherwise entitled under the State law to receive regular compensation, as if such State law had been modified in a manner such that the amount of regular compensation (including dependents' allowances) payable for any week shall be equal to

(A) the amount determined under the State law (before the application of this paragraph), plus

(B) an additional amount of \$600 (in this section referred to as "Federal Pandemic Unemployment Compensation").

. . . .

(f) Fraud and Overpayments

(2) Repayment.--In the case of individuals who have received amounts of Federal Pandemic Unemployment Compensation to which they were not entitled, the State shall require such individuals to repay the amounts of such Federal Pandemic Unemployment Compensation to the State agency...

The administrative law judge concludes that the claimant has been overpaid UI benefits in the amount of \$10,620.00 pursuant to lowa Code § 96.3(7) as the disqualification decision that created the overpayment decision has been affirmed. Because claimant is not eligible for UI benefits, claimant is also not eligible for FPUC benefits. Therefore, claimant has received FPUC benefits to which he was not entitled. The administrative law judge concludes that claimant has been overpaid FPUC benefits in the amount of \$5.700.00. Those benefits must be recovered in accordance with the law.

## **DECISION:**

The decision of the representative dated April 28, 2022, (reference 04) is affirmed. Claimant was overpaid regular state unemployment insurance benefits in the amount of \$10,620.00 to which he was not entitled, and those benefits must be repaid. Claimant has been overpaid FPUC benefits in the amount of \$5,700.00, which must be repaid.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday.

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

1) The name, address, and social security number of the claimant.

2) A reference to the decision from which the appeal is taken.

3) That an appeal from such decision is being made and such appeal is signed.

4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may then file a petition for judicial review in district court.

2. If no one files an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final.
