Iowa Code § 96.3(7) - Recovery of Benefit Overpayment

STATEMENT OF THE CASE:

On June 5, 2023, the claimant Juan C. Sanchez appealed the May 31, 2023, (reference 17) decision that concluded the claimant was overpaid regular unemployment insurance benefits in the amount of \$572.00 for the one-week period ending February 25, 2023. The parties were properly notified of the hearing. A telephonic hearing was held at 9:20 a.m. on Tuesday, June 27, 2023. Appeal numbers 23A-UI-05820-LJ-T, 23A-UI-05821-LJ-T, 23A-UI-05822-LJ-T, 23A-UI-05823-LJ-T, 23A-UI-05824-LJ-T, 23A-UI-05825-LJ-T, and 23A-UI-05826-LJ-T were heard together and created one record. The claimant, Juan C. Sanchez, participated. Spanish/English interpreter Carlos (ID number 14523) from CTS Language Link provided interpretation services for the hearing. The administrative law judge took official notice of the administrative record.

ISSUE:

Is the claimant overpaid regular unemployment insurance benefits?

FINDINGS OF FACT:

Having reviewed all of the evidence in the record, the administrative law judge finds: Claimant filed for and has received regular unemployment insurance benefits in the gross amount of \$572.00 for one-week period ending February 25, 2023. He has received both the individual decisions that state he has been overpaid and a bill-like statement with a total amount owing to Iowa Workforce Development.

On May 2, 2023, Iowa Workforce Development (IWD) issued a decision (reference 09) that disqualified claimant from receiving regular unemployment insurance benefits for the week ending February 25, 2023. That decision has been affirmed. See 23A-UI-04827-DG-T. The administrative record does not show that claimant had appealed this decision to the Employment Appeal Board as of the date of this hearing.

REASONING AND CONCLUSIONS OF LAW:

The administrative law judge concludes claimant has been overpaid benefits for the period in question.

Iowa Code § 96.3(7) provides, in pertinent part:

7. Recovery of overpayment of benefits.


a. If an individual receives benefits for which the individual is subsequently determined to be ineligible, even though the individual acts in good faith and is not otherwise at fault, the benefits shall be recovered. The department in its discretion may recover the overpayment of benefits either by having a sum equal to the overpayment deducted from any future benefits payable to the individual or by having the individual pay to the department a sum equal to the overpayment.

b. (1) (a) If the department determines that an overpayment has been made, the charge for the overpayment against the employer's account shall be removed and the account shall be credited with an amount equal to the overpayment from the unemployment compensation trust fund and this credit shall include both contributory and reimbursable employers, notwithstanding section 96.8, subsection 5.

The decision that denied claimant benefits has been affirmed by an administrative law judge and remains in place at this time. Because claimant is not eligible for benefits, he has been overpaid benefits received that week as a result. The administrative law judge concludes that the claimant has been overpaid regular unemployment insurance benefits in the amount of \$572.00. That amount must be repaid to the agency.

DECISION:

The May 31, 2023 (reference 17) decision is affirmed. Claimant has been overpaid regular unemployment insurance benefits, and those benefits must be repaid to the agency.

APPEAL RIGHTS. If you disagree with the decision, you or any interested party may:

1. Appeal to the Employment Appeal Board within fifteen (15) days of the date under the judge's signature by submitting a written appeal via mail, fax, or online to:

The appeal period will be extended to the next business day if the last day to appeal falls on a weekend or a legal holiday. *There is no filing fee to file an appeal with the Employment Appeal Board.*

AN APPEAL TO THE BOARD SHALL STATE CLEARLY:

- 1) The name, address, and social security number of the claimant.
- 2) A reference to the decision from which the appeal is taken.
- 3) That an appeal from such decision is being made and such appeal is signed.
- 4) The grounds upon which such appeal is based.

An Employment Appeal Board decision is final agency action. If a party disagrees with the Employment Appeal Board decision, they may file a petition for judicial review in district court.

2. If you do not file an appeal of the judge's decision with the Employment Appeal Board within fifteen (15) days, the decision becomes final agency action, and you have the option to file a petition for judicial review in District Court within thirty (30) days after the decision becomes final. Additional information on how to file a petition can be found at www.iowacourts.gov/efile. *There may be a filing fee to file the petition in District Court.*

Note to Parties: YOU MAY REPRESENT yourself in the appeal or obtain a lawyer or other interested party to do so provided there is no expense to Workforce Development. If you wish to be represented by a lawyer, you may obtain the services of either a private attorney or one whose services are paid for with public funds.

Note to Claimant: It is important that you file your weekly claim as directed, while this appeal is pending, to protect your continuing right to benefits.

DERECHOS DE APELACIÓN. Si no está de acuerdo con la decisión, usted o cualquier parte interesada puede:

- 3) Que se interponga recurso de apelación contra tal decisión y se firme dicho recurso.
- 4) Los fundamentos en que se funda dicho recurso.

Una decisión de la Junta de Apelaciones de Empleo es una acción final de la agencia. Si una de las partes no está de acuerdo con la decisión de la Junta de Apelación de Empleo, puede presentar una petición de revisión judicial en el tribunal de distrito.

2. Si no presenta una apelación de la decisión del juez ante la Junta de Apelación de Empleo dentro de los quince (15) días, la decisión se convierte en una acción final de la agencia y tiene la opción de presentar una petición de revisión judicial en el Tribunal de Distrito dentro de los treinta (30) días.
