871 IAC 26.8(1) - Withdrawal of Appeal

STATEMENT OF THE CASE:

Wells Fargo Bank (employer) appealed a representative's October 11, 2004 decision (reference 01) that concluded Al K. Unkel (claimant) was qualified to receive unemployment insurance benefits, and the employer's account was subject to charge because the claimant had been discharged for nondisqualifying reasons. A hearing was scheduled for November 9, 2004. Prior to the hearing, the employer's representative made a request to withdraw the employer's appeal. Based on the employer's withdrawal request, the administrative record, and the law, the administrative law judge enters the following findings of fact, reasoning and conclusions of law, and decision.

FINDINGS OF FACT:

The employer's unemployment insurance representative, TALX, made a request to withdraw the employer's appeal. The November 5, 2004 written request was faxed to the Appeals Section on November 5, 2004.

REASONING AND CONCLUSIONS OF LAW:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The employer's request to withdraw its appeal is approved.

DECISION:

The representative's October 11, 2004 decision (reference 01) is affirmed. The employer's request to withdraw its appeal is approved. This means, the claimant is qualified to receive unemployment insurance benefits as of September 26, 2004, provided he meets all other eligibility requirements. The employer's account may be charged for benefits paid to the claimant.
