Section 96.5-3-a – Refusal of Work

STATEMENT OF THE CASE:

The claimant, Josh Fuller, filed an appeal from a decision dated May 10, 2005, reference 03. The decision disqualified him from receiving unemployment benefits. After due notice was issued a hearing was held by telephone conference call on June 6, 2005. The claimant participated on his own behalf. The employer, McWhirter Chevrolet-Buick, Inc. (McWhirter), participated by Operations Manager Matt McWhirter.

FINDINGS OF FACT:

Having heard the testimony of the witnesses and having examined all of the evidence in the record, the administrative law judge finds: Josh Fuller filed a claim for unemployment benefits

with an effective date of February 20, 2005. His average weekly wage during the base period was \$501.00.

On February 24, 2005, he was offered a job as an auto technician with McWhirter. He could have started immediately at a "flat rate" of \$14.00 per hour, with a bonus of \$1.00 per flat rate hour if he reached 80 percent., The employer offered a minimum of \$8.00 per hour if the work load was not sufficient, however, all the technicians had reached the minimum flat rate in February 2005.

The claimant was not confident we would be able to make the flat rate or that he had the knowledge and ability to work on General Motors vehicles or use the related diagnostic equipment, and refused the job.

REASONING AND CONCLUSIONS OF LAW:

The issue is whether the claimant is disqualified. The judge concludes he is not.

Iowa Code section 96.5-3-a provides:

An individual shall be disqualified for benefits:

3. Failure to accept work. If the department finds that an individual has failed, without good cause, either to apply for available, suitable work when directed by the department or to accept suitable work when offered that individual. The department shall, if possible, furnish the individual with the names of employers which are seeking employees. The individual shall apply to and obtain the signatures of the employers designated by the department on forms provided by the department. However, the employers may refuse to sign the forms. The individual's failure to obtain the signatures of designated employers, which have not refused to sign the forms, shall disqualify the individual for benefits until requalified. To requalify for benefits after disqualification under this subsection, the individual shall work in and be paid wages for insured work equal to ten times the individual's weekly benefit amount, provided the individual is otherwise eligible.

a. In determining whether or not any work is suitable for an individual, the department shall consider the degree of risk involved to the individual's health, safety, and morals, the individual's physical fitness, prior training, length of unemployment, and prospects for securing local work in the individual's customary occupation, the distance of the available work from the individual's residence, and any other factor which the department finds bears a reasonable relation to the purposes of this paragraph. Work is suitable if the work meets all the other criteria of this paragraph and if the gross weekly wages for the work equal or exceed the following percentages of the individual's average weekly wage for insured work paid to the individual during that quarter of the individual's base period in which the individual's wages were highest:

(1) One hundred percent, if the work is offered during the first five weeks of unemployment.

(2) Seventy-five percent, if the work is offered during the sixth through the twelfth week of unemployment.

(3) Seventy percent, if the work is offered during the thirteenth through the eighteenth week of unemployment.

(4) Sixty-five percent, if the work is offered after the eighteenth week of unemployment.

However, the provisions of this paragraph shall not require an individual to accept employment below the federal minimum wage.

The claimant apparently did not feel he was capable of working at a high enough level of efficiency to earn the flat rate, much less the bonus. He also felt he was not capable of using General Motors diagnostic equipment or working on General Motors vehicles, and refused the job. The guarantee of \$8.00 per hour would not have equaled his average weekly wage during his base period and the job offer was, therefore, not suitable under the provisions of the above Code Section.

DECISION:

The representative's decision of May 10, 2005, reference 03, is reversed. John Fuller is qualified for benefits provided he is otherwise eligible.
