STATEMENT OF THE CASE:

Express Services Inc. filed a timely appeal from the February 16, 2012, reference 01, decision that allowed benefits. A hearing was scheduled for March 8, 2012. Prior to the hearing being held, the appellant requested that the appeal be withdrawn.

ISSUE:

871 IAC 26.8(1) provides:

(1) An appeal may be withdrawn at any time prior to the issuance of a decision upon the request of the appellant and with the approval of the presiding officer to whom the case is assigned. Requests for withdrawal may be made in writing or orally, provided the oral request is tape-recorded by the presiding officer.

The administrative law judge has reviewed the records and files herein and concludes that the request of the appealing party to withdraw the appeal should be approved.

DECISION:

The Agency representative's decision dated February 16, 2012, reference 01, is affirmed. The	ne
request of the appealing party to withdraw the appeal is approved and the decision of the	ìе
representative shall stand and remain in effect.
